FACILITY: Six lane, 50 meter pool. Pool depth is 12 feet at the start end and 3 feet at turn end. Blocks are 29.5 inches high. This competition course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4). Please be advised that due to the depth of the non-starting end of the pool, the 2nd and 4th leg of all 200-Yard/Meter relays will start in the water.

TIMING: Colorado System 6 timing system with touch pads at both ends and horn start. Each lane has two timers with electronic stopwatches.

RULES: Official Long Course USA-S Rules shall prevail for this meet. Age is as of June 15, 2012.

TIME: Friday warm ups to start 4:00pm – 5:00pm. The meet starts at 5:05pm.

Saturday warm ups to start at 7:00am-8:00am. The meet starts at 8:05am. The PM warm ups start immediately following the end of the AM Session and will last 1 hour. General warm-ups/circle swimming will be in all lanes for each warm-up session. Push-pace and sprint lines will be opened and closed as necessary by the Meet Director and Meet Marshals. Sit and slide or 3 point entry will be enforced during general warm-ups

SEEDING: This is a pre-seeded meet. It is the swimmer's responsibility to be at the blocks at the start of his/her events. All 8 & Under events will be staged. Please have all your 8 & Under swimmers report to the designated staging area for their events.

ENTRIES Individuals may enter 2 individual events on Friday plus relays, and 4 individual events on Saturday, plus relays. A team may enter an unlimited number of relays in any relay events. Ages are as of June 15, 2012. Swimmers with special needs should be noted on your entry form. Your coach is responsible for notifying the head official during warm-ups of any special needs of your swimmers.

Deck registrations will not be accepted. Deck entries may be accepted to fill open lanes in existing heats only at \$5.00 per individual event and \$14.00 per relay. Deck Entries will close 30 minutes prior to the beginning of each session. A \$2 Splash fee and a \$4 facility fee will be added to any swimmer not already registered in the meet. No deck entries will be accepted without a current USA Swimming registration being shown to the meet director.

ENTRIES & DEADLINE Meet entries due by June 7, 2012. Signed waiver/paperwork and payment due by June 11, 2012. No phone entries will be accepted. All entries must be accompanied with a check covering all team entries. Entries must be sent via Hy-tek Team manager provided that the Team Manager event #'s associate with the Meet manager event #'s and a hard copy of the Team manager entry is included. Name the meet in Team Manager "FSC JUNE 2012". Please check that all swimmers have USA-S memberships and are submitted to the LSC registration chair before the entry deadline.

- ENTRY FEES: \$4.00 per individual events, \$12.00 per relay, splash fee of \$2.00 per individual, facility fee of \$4.00 per individual.
- ADMISSIONS: \$3.00 per spectator over 12 years of age. Heat sheet \$3.00 per session.
- AWARDS: Seniors- None: – 14 & Under ribbons will be awarded 1st-12th place. Relays will be awarded 1st-6th place ribbons.
- FINAL RESULTS: A meet back-up will be posted at www.wisconsinswimming.org
- FOOD: Concessions will be provided throughout the meet.
- CONDUCT: Each team is responsible for the behavior of their swimmers. The meet director or meet marshal may remove any swimmers from the competition for disruptive or disorderly behavior.
In accordance with the Federal Video Voyeurism Prevention Act of 2004 – the use of camera phones or video recording devices in the locker rooms is prohibited.
Any swimmer entered in the meet be certified by a USA Swimming member coach as being proficient in performing a racing start each race from within the water, When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement
