Successful completion of the course includes American Red Cross Lifeguard Training, First Aid, and CPR for Professional Rescuers. All certifications are valid for two years. In order to be certified, participants must attend all classes, demonstrate proficient skills, and pass the written exam with a score of 80% or better. Certification cards will be mailed after successful completion of the course.

- 1. Acknowledge, agree, and represent that I understand the nature of the Activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.*
- 2. I fully understand that: (a) Class participation, especially activities involving skill practice and in-water testing have risks of injury including serious bodily injury or death ("Risks"); (b) Traveling to and from class at the start, end, or break of class, or traveling to separate training sites may involve driving, ride sharing, or otherwise traversing public streets, thereby incurring additional Risks; (c) these Risks may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place or the negligence of the releases named below; (d) there may be other Risks and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such Risks and responsibility for all losses, costs, and damages that I incur as a result of my participation or that of the minor in the Activity.*

I hereby release, discharge, and covenant not to sue the City of Fullerton, The Fullerton Aquatics Sports Team, Inc., their instructors/coaches/leaders conducting the Activity as well as their agents, employees, third party contract instructors, guest speakers, or assistants, the certifying agency of course certificates that are being issued, other course participants, and, if applicable, the owners and lessees of the premises on which the Activity takes place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations, negligent security, and recreational operations and activities. I further agree that if, despite this Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement, if I or anyone on my behalf makes a claim against any of the Releasees, I will indemnify and hold harmless each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which anyone may incur as the result of such claim.*
