

## **Lifeguard Certification Class**

FAST Swimming offers lifeguard training and certification courses. All participants must be at least 16 years of age and have some aquatics experience. Successful completion of the course includes American Red Cross Lifeguard Training, First Aid, and CPR for Professional Rescuers. All certifications are valid for two years. In order to be certified, participants <u>must attend all classes</u>, demonstrate proficient skills, and pass the written exam with a score of 80% or better. Certification cards will be mailed to you after successful completion of the course.

Dates and Times: Saturday and Sunday from 7:30 AM to 5:30 PM. Spring class dates are May 18-19.
