Enrollment Agreement

By signing this agreement I understand that F.A.S.T. will provide instruction, training, and competition events for registered swimmer's in good standing who fulfill the requirements of F.A.S.T. I will abide with the rules, regulations, policies, and payment procedures of F.A.S.T. I understand that F.A.S.T. is a non-profit educational incorporation, sanctioned by USA Swimming Inc. and that ALL swimmers in my family who register with F.A.S.T. must become a member of USA Swimming Inc. Masters swimmers have the option to join USA Masters Swimming Inc. I fully understand that the tuition, registration, and all fees required are payable in advance for enrollment, and there shall be NO REFUNDS. Parents, Guardians, and Sponsors of F.A.S.T. swimmers are responsible for the financial obligations of each swimmer enrolled, and are required to volunteer work at F.A.S.T. swim meets and special events. Every F.A.S.T. swimmer has a financial obligation to F.A.S.T. which includes the quarterly tuition, the annual registration fee, and the family financial commitment obligation (Silver, Gold, Pre-Senior, and Senior levels only).

Tuition is paid quarterly and is due payable on the first day of the month of each quarter. A 'Late Fee' charge of \$25.00 is assessed if payment is received after the 10th day of the month due. Returned checks will incur a service fee of \$50.00. There is a 10% discount in tuition if paid in full for one year. Tuition and fees are based upon the

-most advanced swimmer in the family, and each family agrees to be billed quarterly/annually and will pay the rates set by F.A.S.T. NO REFUNDS. The enrollment period is for one year and may be renewed thereafter by continuing the payment of tuition and fees. Swimmers who are in default of payment will not be permitted to attend practice until their account is paid in full.

To cancel this agreement, you must mail or deliver a signed and dated notice to the F.A.S.T. Head Coach, notifying cancellation of this agreement. All tuition and fees must be paid in full upon termination. Delinquent accounts will be referred to collection and reported to Southern California Swimming Inc.

I agree to the terms and conditions of this agreement, and I shall abide to the policies and procedures established by F.A.S.T. I understand that non-compliance with any of the above, will be reason for suspension or expulsion from F.A.S.T.
