

Open Water Course:	<ul> <li>The open water event will be swum in Lake Andrea with all swims beginning and ending in the beach area. In-water start, in-water finish using finish/slap board.</li> <li>The lake course is pictured on page 6 of the meet information.</li> <li>There is a large spectator area along the beach with ample parking nearby.</li> <li>Swimmers and spectators will have access to the adjacent Pavilion and concession area.</li> <li>The following distances will be swum by age group: <ul> <li><u>10 &amp; Under</u>: ½ mile</li> <li><u>11-12</u>: 1 mile</li> <li><u>Open</u>: 5K (3.1 miles)</li> </ul> </li> </ul>

ENTRY PROCEDURES:	A. The LSC must submit its Open Water entries as one team, using the LSC as the				
	club designation. All individual entries shall be consolidated and submitted as				
	one entry. Separate entries from individuals or clubs will not be accepted. LSC				
	entry chair shall verify times before submitting entries to host.				
	B. Each LSC must identify, on the official entry form, the name of the LSC and the name, address and telephone number, and email of the person in charge of entries for that LSC.				
	C. Each swimmer entry must include first and last name, age as of June 24, 2016 and complete USA Swimming registration number.				
Entry Responsibility:	<ul> <li>A. The coach, swimmer, or swimmer representative who enters any Central Zone</li> <li>Championship Meet thereby attests that all times on the entry are true and correct achieved qualifying times for each event entered and that all entered swimmers are eligible under current rules. He/she assumes all responsibility for false or incorrect times or times which are unacceptable under USA Swimming or Central Zone rules and shall be assessed a \$100 penalty payable to the Central Zone for each false or incorrect entry unless absolved of the fine by the elected officers of the Central Zone, their designee or a Board of Review.</li> <li>Additional action or penalty may be taken or levied as deemed appropriate by the Central Zone or USA Swimming.</li> <li>B. Appeal of fines or penalties imposed is to be made to the elected officers of the Central Zone, their designee, and/or a Board of Review.</li> </ul>

ENTRY DEADLINE:	<ul> <li>A. Open Water entries must be submitted to the host entry chairperson electronically by Monday @ Noon, June 20th, 2016. The hard copy (electronic) of the open water entries must accompany the team entry file. It is the responsibility of each LSC to verify entry times, receipt and readability of any entries, and submission of entry. Entry chair must verify by email or follow-up phone call to the host entry chair.</li> <li>B. Each LSC shall receive a team entry report including an exception report of the LSC team entries via e-mail by 6 p.m. Monday, June 22, 2015. Any corrections to the original entries should be formatted in a new entry file and sent to the entry chair via email by Noon on Tuesday, June 21<sup>st</sup>, 2016. Justification of the exception report should be included in a word document or PDF file. No new swimmers may be added to LSC entries after the Tuesday, June 21<sup>st</sup>, 2016 Noon deadline. Any corrections or updates after Noon on Wednesday shall go to the eligibility jury.</li> <li>C. There will be NO on-site entries at this meet.</li> </ul>				
SEEDING/CONDUCT:	<ul> <li>All swimmers must report to the registration area before they swim to ID Card, body marking, cap, and wave number.</li> <li>Please make sure that fingernails and toenails are trimmed and all jewelry and watches are removed prior to the morning registration.</li> <li>There will be no nonalty for scratching, entry focs will not be refunded.</li> </ul>

- Athletes must notify the Clerk of Course if they decide to scratch from their event after completing registration.
- No swimmer shall be allowed to use or wear any device that may be an aid to his/her speed.
- Swimmers will start in the water, and finish in water (hand touching finish board)
- Each age group (and possibly gender) will start separately.
- D. Colored caps will indicate age group and wave.

DISQUALIFICATION PROCEDURES:

**FINAL RESULTS:** 

A. First Infringement: a yellow flag and a card bearing the swimmer's number shall be raised by the Referee to indicate and to inform the swimmer that he/she is in violation of the rules.

B. Second Infringement: a red flag and a card bearing the swimmer's number shall be raised by the Referee to indicate and to inform the swimmer that he/she is, for the second time, in violation of the rules. The swimmer shall be disqualified. He/She must leave the water immediately and be placed in an escort craft and take no further part in the race. The Referee may disqualify a swimmer without prior warning if in his opinion the action of the swimmer is deemed to be unsportsmanlike.

- TIME LIMITS:All swimmers must finish within 30 minutes of the first swimmer in their heat in<br/>order to place or score points.
- ABANDONMENT: Where emergency conditions require a race to be halted before it is completed, the race shall be restarted at the earliest possible time and the full distance completed. A Meet Committee will be convened if needed.
- SCORING: Open Water events: 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1
- Awards:Individual Open Water events: 1-8 place: medals with neck ribbons;9-16 place: ribbons
- GENERAL ADMISSIONAdmission fee for open water will be free of charge.TICKETS/PARKING:Parking for event is free.
- **MEET PROGRAM/** Psych sheets and final results will be posted at the venue and online.
- **REFRESHMENTS:** Refreshments will be available through RecPlex concessions.
- WARM-UP: Warm-up and warm down area will be in designated beach area adjacent to the open water course. This area will be lifeguard supervised.
- **SPECTATORS:** Picnic tables will be available in viewing area. Spectators are welcome to bring their own lawn chairs and blankets.
- DECK CHANGE POLICY: Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not allowed..

- **ZONE APPAREL:** Zone apparel will be available for purchase on site.
