

**ACAC Dolphin Invitational**  
**Anderson, Indiana**  
**July 13-15, 2012**

- SANCTION:** This meet is being sanctioned by USA & Indiana Swimming.  
Sanction #IN12325 .
- HOST:** Anderson Community Aquatics Club (ACAC), East Side Dolphin Club Swim Team (summer affiliate of ACAC).
- LOCATION:** East Side Dolphin Club located at 3003 Lindberg Road, Anderson, IN 46012.
- FACILITY:** Dolphin Club is a 50 M pool, 9-lane course with separate diving well. Pool depth is 5' at the start end. Colorado Timing System will be used. An outside lane may be used for warm up and cool down if meet is not full. The competition course has not been certified in accordance with 104.2.2C.
- Please bring your own lawn chairs for seating.** Pop tents may be used for shade and placed along the fence. Swimmers and coaches sit on the west side of the pool. Spectators sit on the east side of the pool.
- ADMISSION:** \$1.00 per person, age 13 & over. Children 12 & under are free. Psych sheets will be available at entrance for \$6.00. Concessions will be available all day. There is room to park RV's in the grassy area in front of the club (no connection available). Please let host know in advance of any RV's.
- ELIGIBILITY:** Swimmers must be registered with USA Swimming to be accepted into this meet. Age as of July 13, 2012 shall determine the swimmer's age for the entire meet.
- RULES:** Current USA Swimming and Indiana Swimming rules will govern this meet. Coaches **MUST** constantly display their USA Swimming credentials to gain deck access. The Meet Referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply or card is not valid.
- USA Swimming Rules 202.3.2** - at a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm up, competition, and warm down. The Meet Director and Referee shall assist the athlete in making arrangements to ensure compliance with this requirement.
- Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.01.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the naval or below the knee, and for women shall not cover the neck, extend past the shoulder, nor extend past the knee. Use of audio or visual recording devices, including a cell phone, is not permitted in changing rooms.

**FORMAT:** The meet will be conducted in a Prelim/Finals format except for Friday night events, 9-10 events, 8 & Under events, 800 M Free, and all relays. 11-12, 13-14, and Open age groups will swim Prelims and Finals. Age groups 13-14 and Open will compete together in the Prelims, but separately in the Finals. The top 18 swimmers will swim finals.

ACAC Dolphins reserves the right to limit the number of heats in all events to keep the time line manageable.

ACAC Dolphins reserves the right to use “fly-over” starts for all events.

Those swimming the 1500 are required to provide one timer and one lap counter.

**ENTRY INFORMATION:** Swimmers will be limited to 3 events per day plus 1 relay, except 9-10 and 8 & Under will be limited to 5 events per day. Please note That an 8 & Under swimmer entered in a 10 & Under event may not have a full 15 minutes rest between events. If an entry is submitted with an individual entered in more than this rule allows, he/she will be placed in the first events in numerical order. **Please only use long course meter seed times.** ACAC reserves the right to limit events on Friday evening to ensure a manageable timeline. Hy-Tek Team Manager e-mailed entries are the preferred method of entry. Any club submitting entries on paper must pay a \$50.00 data input fee.

**ENTRY DEADLINE:** Entries will be accepted starting **Monday, May 21** and will close **Friday, June 22**. We will extend the entry deadline if the meet is not full. Be sure to include your team name and contact information with entry.

**FEES:** \$5.00 per individual Prelim/Final event. \$4.00 per individual timed Event. \$6.00 per relay. \$1.50 Indiana Swimming surcharge per swimmer.

**AWARDS:** Dolphin “Team” trophies will be awarded to the top three scoring teams. Individual “High Point” Dolphin trophies will be awarded in each age group/gender. Points awarded in Open events or 10 & Under events will be added to the high point total of respective age group. **Please note all 9-10 and 8 & Under swimmer points will be calculated from Saturday and Sunday events only.** Medals awarded from 1<sup>st</sup> through 3<sup>rd</sup> and ribbons awarded for 4<sup>th</sup> through 9<sup>th</sup>. Awards will be given to coaches of each team after the meet. We will award 9-10 and 8 & Under High Point at the conclusion of the timed finals session on Sunday. We will not mail awards unless a SASE mailer is provided.

There will be a Clerk of Course for all 8 & Under events.

**DIRECTIONS:**

If coming from Indianapolis, take I-69 North to exit 26 (IN-9, 109, Scatterfield Road) and turn left onto IN-9/109/Scatterfield Road. Take Scatterfield Rd. to Lindberg Rd. (You will be on Scatterfield Road approximately 5 miles) Turn right onto Lindberg Rd. Dolphin Club will be on the right, approximately ¼ mile down the road.

If coming from Fort Wayne, take 1-69 South to exit 34. Turn right onto IN-32. Take IN-32 to Rangeline Road. (You will be on IN-32 approximately 4 miles) Turn right onto Rangeline Road. At the 4-way stop, turn left onto Lindberg Road. Dolphin Club will be on the left, less than an 1/8 mile down the road.
