Host: Zionsville Swim Club, Inc. (ZSC)

Location: Zionsville Aquatic Center

Facility: Eight-lane 25 yard pool with Daktronics timing systems and 8 lane score board. Balcony seating for spectators overlooks pool. Concessions will be available. The diving well will be available to warm-up and cool-down.

The minimum water depth, measured in accordance with Article 103.2.3, is 5.0 feet at each end of the pool.

The competition course has not been certified in accordance with 104.2.2C(4).

On Friday, enter through door 31 on the southeast side of the pool by the tennis courts.

On Saturday and Sunday, enter through door 37 on the south side of the school.

Closed Invite: This will be a closed invite meet limited to 4 teams other than ZSC.

Rules: Current USA Swimming and Indiana Swimming rules will govern this meet. Swimming Rules 202.3.2 – At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Coaches MUST constantly display their USA swimming coach credential to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply or card is no longer valid/current.

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming rule 205.101.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

Eligibility: Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of January 18, 2013 shall determine the swimmer's age for the entire meet.

***Indiana Swimming does not process on-site athlete registration.

Entry Limitations: Each swimmer will be limited to 4 individual events and one relay each day of the meet. If an entry is submitted with a swimmer in more individual events than allowed, the swimmer will be entered into the order of events until the rule is satisfied. Both short course yard and long course meter times will be accepted. Long course meter times will be converted by HyTek Meet Manager to determine seeding. If submitting meter times, please make sure your entry is correct.

Limited Events: The number of entries in events may be limited in order to finish before 9:00 PM Friday night or to stay under the 4 hour limit per session Sat. and Sun. It is not our intent to limit the Open 1650 Yard Freestyle on Saturday – but we reserve the right to limit the heats in this event should the number of entries warrant. All participants in the 1650 freestyle will be required to provide one timer and one lap counter.

Refunds: In any meet sanctioned by Indiana Swimming other than Championship

Meets, the host team shall limit the number of swimmers in any one or more events to maintain a reasonable length of the meet. In the event that entries are limited, the host team must return the entry fees to the club(s) whose swimmers are not allowed to compete in the specific event(s).

Fees: \$4.00 per individual event and \$6.00 per relay. Make checks payable to Zionsville Swim Club. Fees must accompany each team's entry if sent by mail and must be received before Friday PM warm-ups if a team sends an email entry. If deck entries are allowed, the fee will be \$8.00 per individual event and \$12 per relay. There will be no refunds issued for any missed or scratched events. In addition, per Indiana Swimming, all sanctioned meets must charge a \$1.50 surcharge fee per athlete.

Check In /Scratch: This is a POSITIVE SIGN-IN MEET. Positive sign-in means, "I'm here. I intend to swim." To sign in positively, highlight swimmer's name on sign in sheets. The deadline for positive sign-in will be 45 minutes before the start of each session. At the deadline, the sheets will be removed from the wall and no changes or corrections will be accepted. Swimmers who do not sign in will be scratched. After scratches are pulled for each session, the events for that session will be seeded, and the heat sheets will be posted at various locations on the pool deck. Swimmers will be expected to read the posted heat sheets and report to the correct heat and lane when it's time for them to swim their event.

Clerk of Course: This will be a no clerk of course for swimmers age 9 and OVER.

A clerk of course will be used for 8 and under swimmers. 8 and under swimmers should assemble on the designated bleachers in the clerk area prior to their events. They will be separated by heats and escorted to the starting blocks.

Seeding: Short course yard times will be used for seeding. Long course meter times submitted should be identified as such, and will be converted to yard times for seeding. "No time" entries will be seeded last.

Awards: Ribbons will be given for 1st through 12th place in individual events and 1st through 6th place relay events. Open events will be scored separately for different age groups and ribbons for each age group will be awarded. All 13 and Over events will be scored separately and awards will be given for 13-14 age group and 15 and over age group.

Entry Deadlines: Entries will be accepted starting December 10, 2012. Entry deadline will be January 4, 2013. The deadline will be extended if the meet is not full. At the discretion of the entry chair, late entries may be accepted.

Deck entries will be allowed if in the judgment of the meet directors they will not

materially delay the meet. In that case, deck entries of NEW swimmers to the meet will be accepted if the entering swimmer can provide a current USA Swimming card to the host. Supplying the ID # is NOT sufficient. If such a card (or copy) is not presented, a USA Swimming registration fee will be due before entry can be accepted. If swimmer has such card, but does not have it at meet, the fee is still due. Indiana Swimming will return the fee if application is proven to be a duplicate.

**Entry
Format:**

The following must be submitted to the entry chair by the entry deadline:

If you submit by mail, include:

- HYTEK Commlink file for all entries on a CD-ROM. Nonconforming times will be converted by HyTek Meet Manager. Hand entries will not be accepted.
- Hard copy printout of your Commlink file must accompany disk entry, and will be the basis for any problems regarding that entry.
- Team summary report and executed release, and hold harmless agreement (included in this packet)
- Check for payment of all entry fees made out to Zionsville Swim Club.

If you submit an entry file by email, within 3 business days of receipt of email acknowledgement, mail the following:

- Team summary report and executed release, and hold harmless agreement (included in this packet)
- Check for payment of all entry fees made out to Zionsville Swim Club.
