Facility: The North Central Natatorium will use a 50-meter 10 lane competition pools with 10 lanes and Keifer-McNeil non-turbulent lane markers. Competition will take place in eight lanes with one lane reserved for continuous warm-up & warm-down. The minimum water depth, measured in accordance with Article 103.2.3, is 5.0 feet at each end of the pool. The competition course has not been certified in accordance with 104.2.2C(4). Enter through door #24 on the southwest side of the school.

Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Closed Invite: This will be a closed invite meet limited to 4 teams other than ZSC.

Rules: Current USA Swimming and Indiana Swimming rules will govern this meet. Swimming Rules 202.3.2 – At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Coaches MUST constantly display their USA swimming coach credential to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if coach does not comply or card is no longer valid/current.

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in USA Swimming rule 205.101.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.

Eligibility: Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of June 27, 2015 shall determine the swimmer's age for the entire meet. Indiana Swimming does no process on-site registrations.

Entry Limitations: Each swimmer will be limited to 5 individual events each day of the meet. If an entry is submitted with a swimmer in more individual events than allowed, the swimmer will be entered into the order of events until the rule is satisfied. Short course yards times will be converted by HyTek Meet Manager to determine seeding. If submitting meter times, please make sure your entry is correct.

Limited Events: The number of entries in events may be limited to stay under the 4 hour limit per session Sat. and Sun. It is not our intent to limit the Open 1500 Meter Freestyle on Saturday – but we reserve the right to limit the heats in this event should the number of entries warrant. All participants in the 1500 freestyle will be required to provide one timer and one lap counter.

Refunds: In any meet sanctioned by Indiana Swimming other than Championship Meets, the host team shall limit the number of swimmers in any one or more events to maintain a reasonable length of the meet. In the event that entries are limited, the host team must return the entry fees to the club(s) whose swimmers are not allowed to compete in the specific event(s).

Fees:

- \$2.00 per swimmer Indiana Swimming surcharge
- \$4.00 per individual event.
- \$6.00 per relay event.
- \$8.00 per individual event for deck entries if allowed.
- Make checks payable to Zionsville Swim Club.
- Fees must accompany each team's entry if sent by mail and must be received before Saturday AM warm-ups if a team sends an email entry. If deck entries are allowed, the fee will be \$8.00 per individual. There will be no refunds issued for any missed or scratched events. In addition, per Indiana Swimming, all sanctioned meets must charge a \$2.00 surcharge fee per athlete.

Seeding: Long Course meters times will be used for seeding. Short course yard times submitted should be identified as such, and will be converted to meter times for seeding. "No time" entries will be seeded last.

Awards: Ribbons will be given for 1st through 16th place for each event. 8 & unders will be awarded separately from 9-10 year olds in the 10 & Under events.
