Modern 6 lane, 50-meter outdoor pool, with 15 yard diving well for warmup/cooldown. Water depth at 3' and 16.5' from start end ranges from 5 to 7 feet. Water depth at turn end is a consistent 3.5' at both 3' and 16.5'. The competition course has not been certified in accordance with 104.2.2C(4).

Our splash park will be open for families.

Ample deck and lawn space are available.

The concession stand will be open for business during the meet.

Timers: Each swimmer must provide at least one timer (required) and if desired, a lap counter.

Entry Deadline: Entries may be submitted beginning April 29, 2016 and no later than May 20, 2016. The entry deadline will be extended if the meet is not full. In order to create an accurate timeline, all swimmers must be entered with a LCM time. ***Coaches please estimate as accurately as possible for swimmers who have not yet completed one of the events.***

Rules: All swimmers must be registered with USA Swimming to be accepted into this meet. Age as of the first day of the meet, June 3, 2016, will determine age for the entire meet. Indiana Swimming does not process on-site registrations. Current USA and Indiana Swimming rules will govern this meet. The "no recall" procedure will be observed for all events in this meet. Fly over starts may be used at the discretion of the referee. Coaches MUST constantly display their USA Swimming Coach credentials to gain deck access. The meet referee reserves the right to ask for coaches to display their credentials and or deny deck access if a coach does not comply or card is no longer valid/current. USA Swimming rule 202.5.2 states that a sanctioned competitive event, USA Swimming athlete members must be under the direct supervision a USA Swimming coach during warm-up, competition, and cool down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision. Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal

guardian to ensure compliance with this requirement. In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.1. All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulder, nor extend below the knee.

The following rules will be strictly enforced:

1. Keep all trash picked up (swimmers and teams in particular)
2. Do not go in unauthorized areas. This means any place other than the seating areas, spectator restrooms, and concession areas. Due to USA Swimming Insurance requirements, ONLY USA Swimmers, coaches, officials, and volunteers are allowed in the competition area of the pool deck. There will be no exceptions.
3. Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms, or locker rooms.
4. Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.

Format: There will be no penalties for missed events, other than not being allowed to swim the event. All events are TIMED FINALS. This meet will be run with split sessions Saturday and Sunday. Though our goal is to schedule every swimmer entered, Putnam County Swim Team reserves the right to limit the number of heats in all events if necessary. There will be refunds for any limited event. Heats will run fastest to slowest, alternating female and male heats.

Seeding: *There are no time requirements for this meet.* All events will be seeded by time, fastest to slowest, with genders mixed. Age group results will be separated out, but age groups will be mixed in competition. ***Coaches please estimate as accurately as possible for swimmers who have not yet completed one of the events.***

Check-In: There will be no check-in or reseeding for any of the sessions. All accepted entries will be seeded prior to the meet and coaches will be notified of the timeline for each session. No refunds will be made for missed events. Though highly unlikely, Deck entries may be accepted if time is available in a session. It never hurts to ask.

Warm-Up: One hour before the morning sessions and one hour before the start of the afternoon session.

Entries: Entries may be submitted beginning April 29, 2016 and no later than May 20, 2016.

- \$4 event fee + \$2 facility surcharge for each swim. \$2 per swimmer Indiana Swimming surcharge.

The following must be submitted by the entry deadline:

- Team Manager .zip entry file delivered by email
- NT entries will not be accepted. ***Coaches please estimate as accurately as possible for swimmers who have not yet completed one of the events.***
- 10u swimmers may enter the 200 free or 200 individual medley with NT.

Within 3 business days of receipt of PCST's email entry confirmation you must mail:

- Team summary report and executed release and hold harmless agreement
- Check for payment of all entries made out to Putnam County Swim Team
- Times should be submitted in LCM
- Entries should be emailed to: jhansen4@me.com

Final acceptances of email entries are contingent upon receipt of summary report and entry fees. Entry fees not finalized and collected prior to the Saturday session may result in a \$50 surcharge. Any adding/removing of swimmers or events after acceptance to the meet should be done with a complete new entry file for the entire team and must be accompanied by written list of those changes. Time changes only by team entry file.
