



**MISSISSIPPI SWIMMING, INC.
8 AND UNDER SUMMER DEVELOPMENTAL MEET
JULY 17, 2008**

- SANCTION:** Held under the sanction of USA Swimming and Mississippi Swimming, Inc. Sanction MSI#0820
- LOCATION:** Delta State University Aquatic Center, Delta State University, Cleveland, MS 38733. Phone: 662.846.4730
- FACILITIES:** 8 Lane, 25-yard course, lane lines, Colorado Timing System with scoreboard; starting blocks; concessions; ample bleacher seating; first aid and hospitality for coaches and officials will be provided.
- RULES:** Current USA Swimming rules will govern the conduct of the meet.
- ELIGIBILITY:** Current USA Swimming registered swimmers who are members in good standing with MSI. The swimmer's age on July 17, 2008, will determine the swimmer's age group for the meet.
- COACHES:** Coaches must be current USA coach members in order to perform deck duties. If a coach is not certified, he/she may not coach or sit in the coaches' area. The coaches' packets will be given to those coaches presenting credentials.
- SEEDING:** This meet will be seeded according to USA Swimming ruled for timed finals. Entry recaps submitted without times and will be seeded as no time (NT). Entries must be submitted in short course yard times.
- LIMIT OF EVENTS:** A swimmer may swim 5 individual events and 2 relays.
- SCHEDULE:** Warm-ups: 8:30-9:20A.M.
Competition: 9:30 A.M.
- WARM-UPS:** Warm-ups and safety procedures will follow MSI guidelines. The first 30 minutes will be general warm-ups, NO DIVING. In the last 20 minutes, the two outside lanes will be for pace, all swimmers leaving the wall from a push. Lanes 2 & 7 are for dives off blocks with one way traffic. The remaining lanes are for general warm-ups, NO DIVING.
- ENTRY FEES:** \$3.00 per individual events
\$8.00 per relay event.
\$5.00 per swimmer for MSI surcharge (includes relay only swimmers).

ENTRIES:

All entries must be received no later than midnight on *Friday, July 11, 2008*. Entry fees must accompany the entry forms. Each team must send carefully and completely filled-out forms, recaps, and fees. Each team is strongly encouraged to submit their meet entries via disk for Hy-Tek program. When submitting disk, please be sure to include the entry form sheet with release, your print-out of entries, and the entry fee. You may also e-mail entries.

NO LATE ENTRIES WILL BE ACCEPTED!

PLEASE NOTE: A person responsible for entering an unregistered swimmer as "registered" will be subject to a fine of up to \$100.00 per event. This will be enforced by the Mississippi Board of Review.

SCORING:

No score, no high point.

AWARDS:

Medals for 1st-8th place; ribbons for 9th-16th place.

SCRATCHES:

No swimmer may scratch from an entered event and then enter another event. No swimmer may enter a later event to make up for a missed event.

REPORTING:

Swimmers in all events will report directly to the starting blocks. It is the responsibility of the coach and the swimmer to see that the swimmer reports to his/her assigned lane at the proper time. **THERE WILL BE NO CLERK OF COURSE OR BULLPEN.**

OFFICIALS:

Each team will be asked to provide timers according to the number of swimmers competing. All timers should report to their assigned lanes no later than 10 minutes before the start of each session. A list of timing assignments will be posted with the warm-up lane assignments, and a copy will be enclosed in the heat sheet.

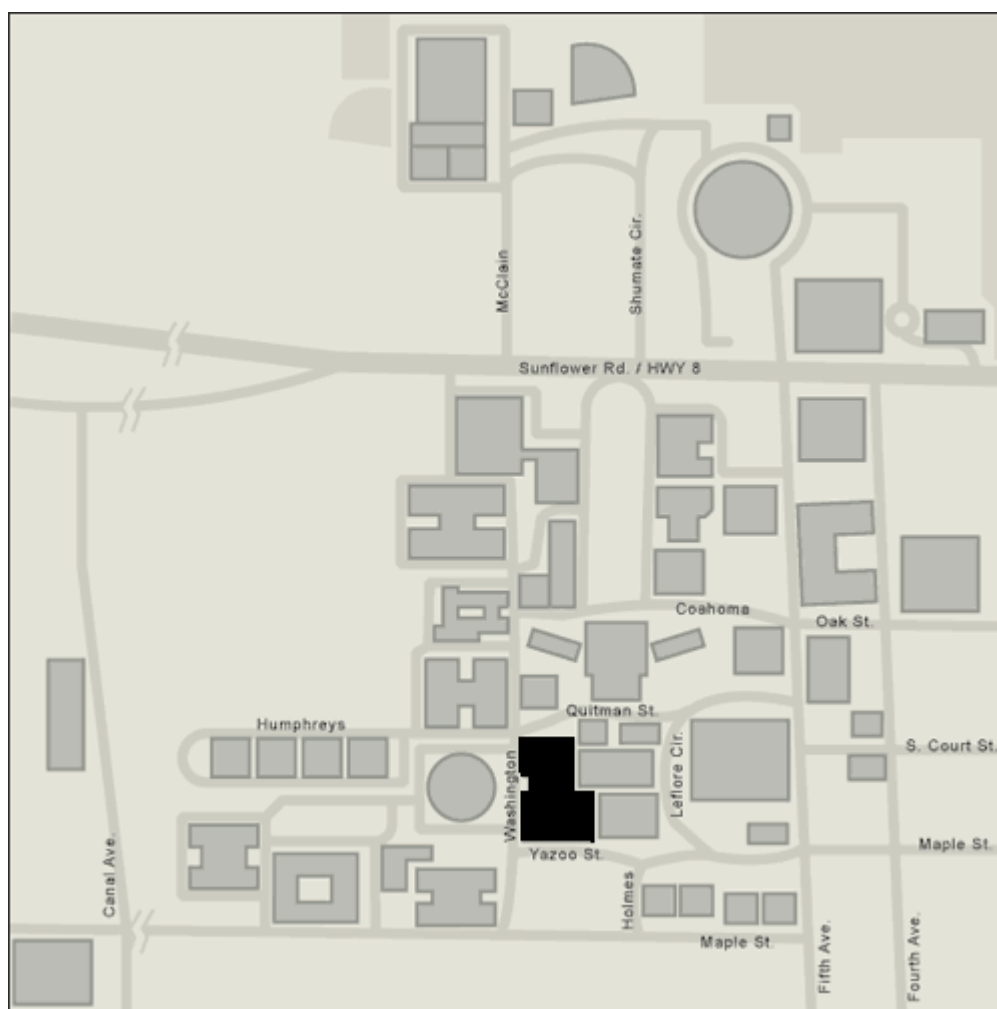
