This meet is sanctioned by USA Swimming and Indiana Swimming. Sanction #IN10062

Host

South Dearborn Swimming

Location

South Dearborn High School
5770 Highlander Drive
Aurora, Indiana 47001

The high school is located on SR 350 just west of West US 50 in Aurora, approximately 25 miles west of Cincinnati and 90 miles southeast of Indianapolis.

Facility

The 25-yard pool consists of six lanes separated by non-turbulent lane markers. A Colorado timing system with horn start, touch pads, and a 64X96 CTS Mercury scoreboard will be used. Spectator seating will be available in the pool area.

Rules

Current USA Swimming and Indiana Swimming Rules will govern this meet.

Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of Friday, November 13, 2009 shall determine the swimmer's age for the entire meet.

Coaches MUST constantly display their USA Swimming coach credential to gain deck access. The meet referee reserves the right to ask for coach credential display and/or deny deck access if a coach does not comply.

USA Swimming Rules 202.3.2 - At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.

In swimming competitions, the competitor must wear only one swimsuit in one or two pieces except as provided in 205.10.1 All swimsuits shall be made from textile materials. For men, the swimsuit shall not extend above the navel nor below the knees, and for women, shall not cover the neck, extend past the shoulders, nor extend below the knees.

Format

All events will be timed finals. Friday's event (1650) will be limited to the top 12 swimmers in each event. Swimmers in the 1650 will need to provide their own counter.

In addition, Friday's other events may be limited in order to maintain a reasonable length. Any teams with swimmers who do not make it into a distance event will be notified. Refunds WILL be given for those swimmers not making the "cut." All other entries will be limited to 1200 swims per day and/or the four-hour session length. On deck entries will be accepted up to the four-hour limit, provided a new heat does not have to be created, at a cost of \$6.00 per event. These may be done up to 30 minutes before the session begins.

Scoring

Scoring for twelve (12) places will be used. Breakout scoring will be used in the following manner: 12 and under will score as 6 and under, 7-8, 9-10 and 11-12; 10 and under will score as 6 and under, 7-8 and 9-10; and, 13 and over will score as 13-14 and 15 and over.

Entries

Each swimmer may swim five (5) individual events and one relay per day. All times should be submitted as yard times. "No time" entries will be accepted. The meet will run with HyTek's Meet Manager software; therefore disk entries are encouraged, and priority will be given to those teams entering on HyTek. All fees must accompany the entry. Individual events are \$4.00 per event, and relay events are \$6.00.
