Entry by INVITATION ONLY.** Entries must be received no later than 12:00p.m. on **Monday, Nov. 9, 2009 - NO EXCEPTIONS.** We encourage HYTEK entries made via e-mail in HY-TEK form to CMentries@fuse.net Please forward a hard copy of your entry with your payment. No Team will be permitted to participate unless their Fees are paid in full. **Entries will be limited to 4000 swims.**

DECK ENTRIES: **NO DECK ENTRIES Will be accepted.**

ENTRY FEES: \$4.00 per individual event, \$7.00 per Relay and \$2.00 surcharge per swimmer. All entry fees must accompany entries to complete the entry process. **Please pay by check made payable to the Cincinnati Marlins, Inc.** All fees must be paid before you will be allowed to swim.

RULES: Age on first day of meet will determine eligibility for age group divisions. Current USA Swimming rules will govern the meet. Swimmers aged 11 & Over may compete in the Open events. All swimmers are limited to entering in 4 Individual events per day plus Relays.
Teams may enter as many relays as they wish but only two (2) may score in each age group.

TIME STANDARD: No Time Standard

ELIGIBILITY: All swimmers must be registered with USA Swimming. Registration numbers and swimmer age must appear on the entry forms. **All SWIMMERS MUST BE PREPARED TO PROVE USA SWIMMING REGISTRATION.**

SEEDING: This meet is a combination of invitational and dual meet seeding. Teams may enter an unlimited number of qualified swimmers in each event. **Each team will indicate their top 3 swimmers to compete in the fastest two heats by designating them as BONUS Swimmers.** All other non-designated swimmers in the field will be seeded fastest to slowest.

SCORING: Scoring Top 20 Individual places. Only Five (5) Swimmers from each Team will be eligible to score points in each event. **Friday night events are NOT SCORED.**
Individual : 24,21,20,19,18,17,16,15,14,13,11,9,8,7,6,5,4,3,2,1.

Scoring Top Eight(8)Relays. Only Two(2)relays from each team will be eligible to score.
40,34,32,30,28,26,24,22.

AWARDS: Medals – First through Third place – Ribbons Fourth through Twentieth place.
Relays - Medals First Place – Ribbons Second through Eighth.

FINAL RESULTS: Posted on the Marlins Web site at www.cincy-marlins.com

SAFETY: Ohio Safety guidelines will be enforced in the conduct of the meet as well as warm ups. General Warm-up procedures require swimmers to enter the pool feet first in a cautious manner, with one hand on the deck.

COACHES: **ALL COACHES MUST SIGN IN FOR EACH SESSION AND PRESENT A CURRENT USS MEMBERSHIP CARD UPON ENTERING THE POOL.** This card must be worn while the coaches are on the pool deck. Ohio Swimming requires the Cincinnati Marlins to enforce this rule. The Marlins are happy to provide a Coaches Hospitality Area at our meets. Please indicate the number of coaches that will be attending the meet with you on the Entry Summary Sheet so that we can provide heat sheets for everyone.

DIRECTIONS:

From I-75 take Exit 9 and go north on Paddock Rd. (Rt. 4) to North Bend Rd. (The first left turn after crossing under the railroad trestle). Turn left and follow North Bend Rd. to the top of the hill (about 1-1/2 miles) . St. Xavier High School is on the right and Keating Natatorium is behind the school.
