Entry Limit: Swimmers may enter a maximum of three (3) individual events.

Entries: Submit YARDS times for seeding purposes. Please submit entries on Hytek meet management software formatted diskette if at all possible. Entries may be submitted on master entry if Hytek is not available.

Facility: Indoor, 8 lane, 25Y. 8 lane 30 yds warm up pool available during meet for warm ups and warm up and warm down. Pool depth ranges from 7 feet in starting end, to 7 feet in turning end. Parking available, seating for approximately 250 spectators.

Restrictions: TOBACCO PRODUCTS OF ANY KIND, ALCOHOLIC BEVERAGES AND GLASS CONTAINERS ARE NOT ALLOWED IN THE SWIMMING VENUE.
