Qualifying Criteria:

Junior Bonus: Achievement of a Junior Bonus standard (Aug 09meet) in the previous 12 months

- May not have achieved a junior national, senior national, or World Champs trial time standard
- Must be 18 or under
- Proof of travel and participation in any qualifying event

Junior National time standard (Aug .09meet): Achievement of a Junior national time standard within the meet qualifying period

- Proof of travel and participation in any qualifying event

US Open/World Champs trial time standard (July/August meets): Achievement of a US Open/world champs trial time standard within the meet qualifying period

- Proof of travel and participation in any qualifying event

*Teams may claim travel funds for a qualifying swimmer from only a single fund during each funding season. However, if, during a season, a swimmer who has qualified for funding from one fund qualifies for another higher level fund (i.e., National Development to Junior National), the team may request to receive the difference in funds as long as the request is made within the time limits. All Travel funds will go directly to the team for team disbursement

Coaches can apply for funds in **each** of the travel funds in which they have qualified athletes according to the following schedule, provided they are in attendance at the meet, but cannot receive two shares for attendance at one meet, unless more than one coach is in attendance.

- 1-6 athletes: equivalent to 1 swimmer in the applicable fund (i. e., 1 share)
- 7-12 athletes: 2 shares
- 13 & more athletes: 3 shares

Teams may receive no more than 3 coaching shares per travel fund level/category, regardless of how many coaches/chaperones attended.
