



# Swim Event Registration

*Please fill out this form in order to participate in the SWIMMING EVENT portion of the evening.*

**Step 1:** Fill out the bottom of this form and return it, along with your event entry fee, ASAP. You can return it to the Hydro-Sonic office, to Coach Jorge, or to Coach Nathan. The entry fee is \$20 per swimmer. Included in this cost is a t-shirt and dinner for the swimmer. Please make this money payable to "Mercedes Silva."

**Step 2:** Ask your coach what your swimming goal should be for the event. Write that number down at the top of your Pledge Sheet.

**Step 3:** Ask your friends, neighbors, and family members to sponsor you for your swim. The amount you will swim is set beforehand by you and your coach. As you get your sponsors, you should write down each sponsor's information on your Pledge Sheet AND collect the money at that time. People should write these checks to "MDA"; the MDA, which is the Muscular Dystrophy Association, will use our donations to fund research for an ALS cure.

**Step 4:** When you are done collecting, put all of your donations and your Pledge Sheet in your envelope, and turn it in. Please bring it with you that night.

**Step 5:** Show up the night of Abuela's Swim ready to swim and have fun! Bring your family and friends along to eat and shop at Abuela's Auction.
