

2009 TG Holiday Mini-Meet

Meet Location: Westside Aquatic Center, 2700 Blue Ridge Drive (S.C. Highway 253), Greenville, South Carolina. (864) 295-0032.

Host: Team Greenville and Greenville County Recreation District.

Facility: Westside Aquatic Center is an indoor climate controlled facility with an eight lane 50 meter pool and adjacent diving well. A stainless steel bulkhead is installed for short course competition. Meet will be conducted in the 25 yard end. Warm-up/warm down will be held in the 25 meter end. Pool is bottom striped and wall targeted. It is equipped with non-turbulent lane lines. Bleacher seating is available for spectators along with ample deck space for swimmers.

Rules: The meet will be conducted according to 2009 USA Swimming rules and regulations, S.C.L.S.C. rules and regulations, and this meet information. Only coaches, officials and swimmers will be allowed behind the blocks during warm-up and competition.

Fees: \$17.00 per swimmer. \$19.00 per swimmer for out of state swimmers. This includes \$12.00 entry fee, \$3.00 facility surcharge, and \$2.00 SCLSC travel program fund. An additional SCLSC surcharge of \$2.00 will apply to all out of state athletes.

Make checks payable to Team Greenville. Late entries will be charged double the meet entry fee.

Eligibility: This meet is open to all 8 & Under. 9-12 year old may swim as long as they do NOT have any current State Championship Meet qualifying times. No awards to any 13 & Over that enters with an "A" time in that event. ***This meet is developmental in nature and not designed for experienced swimmers.*** The first 200 swimmers entered will be accepted. *Swimmers may swim four individual events.* All coaches must be a current member in good standing with USA Swimming and present their credentials to receive their coaching packet.

Entries: Please use swimmer's full name, age, and short course yards entry times. ENTRIES ON DISK USING SD3 FORMAT ARE STRONGLY ENCOURAGED. THOSE CLUBS OR INDIVIDUALS NOT SUBMITTING ENTRIES ELECTRONICALLY WILL BE SUBJECT TO A \$10.00 PER SWIMMER ENTRY SURCHARGE. Go to www.hy-tek ltd.com to download Team Manager II Lite if your club does not possess team management software. You must submit paper back-up copy and your signed team summary sheet for verification.

Timing: Colorado timing system and data processing services provided by TG Timing.

Awards: Ribbons and other "fun" awards.

Seeding/Format: All events will be contested as timed finals. All events will be swum mixed girls and boys. Meet management reserves the right to seed the meet 8 & Under, 9-12, and 13 & Over. No refunds will be given.

Time of the Meet: Warm-up 12:30 PM . Meet starts at 1:15 PM

Entry Deadline: *ALL Entries must be received by midnight, Wednesday, November 25, 2009. Entries received after the deadline will be considered late and handled as deck entries!*

Officials: Certified officials willing to work are most welcome. Please report to the meet referee.

Directions: Take Interstate 385 North into Greenville. Go through town past the Hyatt on your left and County Library on your right. Take S.C. 183 towards Pickens. At S.C. 253 turn left on to Blue Ridge Drive. Pool is about one mile on right.

From Interstate 85 take exit 44 (White Horse Road, U.S. 25 By-Pass). Go north on 25 for approximately five miles. Turn right on S.C. route 253. Pool is in a large blue building about one-half mile on the left.

Warm-up Procedures: Team lane assignments will be made for each session. All S.C.L.S.C. and USA Swimming safety guidelines will be enforced. Warm-up/warm down area open at the discretion of the meet referee.
