- Facilities:** Indoor 6-lane 25-yard pool with Competitor non-turbulent lane lines. Colorado electronic timing system, with touch pads & plungers, will be used. Stop watches will also be used. Limited bleacher seating is available. Spectators may bring chairs. All other areas will be considered the deck, on which only swimmers, officials, coaches and meet personnel are allowed. A concession stand for drinks and snacks will be available. Coolers are not permitted in the facility.
- Rules:** Current United States Swimming Rules will govern the meet. The Meet Referee reserves the right to adjust the warm-up times & start times.
- Meet format:** All events will be contested as Timed Finals.
- Entries:** HY-TEK Meet Manager software will be used. Please submit entries in HY-TEK TEAM MANAGER format. Please include printout of each swimmer's entries to be used as a back up. Include first name, middle initial and last name; age; USAS number; seedtimes. Also include the signed and dated release form and summary found attached to this announcement. Entries are due by October 28<sup>th</sup>, 2009.
- Eligibility:** This meet is the second meet in a closed circuit. The teams within the circuit include Southern Marlins Racing Team (SMRT), Mt. Pleasant Swim Club (MPSC), Myrtle Beach Swim Team (MBR), and Coastal Aquatics (CAC). The entry limit for this meet is the first 150 swimmers. Swimmers do not need to be registered with SC Swimming to enter the meet. All times achieved by swimmers who are registered will be recognized by USA Swimming; times of USA Swimming members are eligible for inclusion in SWIMS database. Swimmers may not swim in events for which they have a short course state cut. Also, any 10 and under who ages up before the state meet and does not have the 11&12 state cut may swim.

**Fees:** Entry Fee \$17.00 per swimmer. Make checks payable to ABC of SMRT. Entry fees are non-refundable. The Clerk of Course will accept entries, on the deck, for lanes available only and time permitting. Payment for all deck entries is due before the end of warm-ups to Clerk of Course.

**Awards:** Ribbons will be awarded to swimmers who earn new “best times”.
