- VII. <u>Coaches Report:</u> LSC allowed 4 swim camps. Outreach and Adapted Swimming review.
- VIII. Athlete Report: Convention review by Amber Lyvers. Will Baumgardner elected Senior Athlete Rep. Amber Lyvers will serve as Jr. Rep. Motion Passed Unanimously: Rules change "Athlete Representation": Attachment #5. (Change allows each club to have 2 voting members to the Athlete Committee. All athletes invited and can voice opinions but cannot vote. Junior Athlete Rep. to Board will move to Senior Athlete. Junior athlete must have completed 3 years of competitive swimming and must be at least in 8th grade up to entering 10th grade. Both representatives are required to attend USAS. Jr. and Sr. Reps will be elected by Athlete Committee.)
- IX. <u>Safety Chair:</u> Johnathan Haggerty has been appointed to serve as a replacement for Jared Hisle.
- X. Officials Chair: The LSC currently has only 15-20 deck referees. Clubs asked to review with deck protocol with parents.
- XI. <u>Records Chair:</u> Records set by athletes at out of KYLSC meets require official meet results be submitted to Records Chair by the club coach or club representative. All KYLSC meets are updated automatically.
- XII. Membership: 2095 athletes registered in Ky Swimming this year, an increase of 75 over 2002. LAA club is dissolving, Mark Williams retiring. MYST also in process of dissolving club.
- XIII. <u>Rules Chair:</u> Marvin Watson reviewed rules changes. Complete changes will be posted to the Web Site where clubs can download the Policy and Procedures Manual. Clubs will be contacted when process is complete.
- XIV. Old Business: None
- XV. New Business:
 - A. Motion/Defeated: Mike Essig proposed to do away with LC State B and move 8 & U to State A.
 - B. Motion/Withdrawn: George Hubbard proposed to rename B Champs for both LC and Sc to State A Qualifier.
 - C. Motion/Passed: Eliminate individual high point awards at B Champ Meets.
 - D. Motion/Passed: To determine large and small team assignments at state B Champs by formula of: Total number of teams divided by 2 with teams entering the largest number of swimmers in Large Team Division and the teams with fewest in Small Team Division.
 - E. Motion/Passed: To retain rule #2365 "Failure to Participate in All Start Meet".

- F. Motion/Passed: Add Adapted Swimming Chair position to Board of Directors. This will include Outreach and Special Olympics. Dave Montgomery will assume position.
- G. Motion/Passed: Dave Doolin will serve as both Coach Rep. and Program Development until Spring HOD.
- H. **Motion/Defeated:** To put Program Development under Coach Rep. therefore eliminating a Board position.
- I. Motion/Passed: By-Law change to put Board of Review Chair in to the Administrative Vice Chair position as facilitator in non-voting capacity. The chair can appoint 3-5 panel members to include a minimum of 1 athlete, 1 coach and 1 non-athlete/ non coach. If 5 are chosen, 2 will be coach members. All must be registered with USA Swimming.
- J. Motion/Passed: Change Bylaws for Club Safety chair 602.2.3 to read Non-athlete and coach...
 - K. Motion/Passed: Nominating Committee: Past General Chair, Dan Petry; Laura Clark, Jim Rogers, Mike Essig, and Rick Baumgardner.
 - L. LC 2004 Meet Bids: Final calendar will be posted to web site. KYLSC will be Host Club for LC State B and 8 & U. Dolphins will serve as Home Club for State A LC. Detailed responsibility of Home/Host will be posted to web site upon revision.
