Officials Chair: We currently have 208 Officials, 20 Referees, 17 Starters and 148 Stroke and Turn. Thirteen teams failed to meet the minimum requirement of 1 official for every 10 athletes. It is the responsibility of the Club Official Rep. to ensure the club has complied with Rule #3190. Starter and Referee Clinics will be offered at the Fall HOD as well as a review of the new National Certification program.
