- Facility:** 7 lane, 25 yard pool. Pool depth is 13 feet at the start and 5' 10" at the bulkhead (turn end). 30" Blocks with non-turbulent lane markers. **The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2(c).**
- Timing System:** Colorado 6 Timing System will be used with a manual back-up button, plus two back-up timers for each lane. Should the automatic system fail, a gun or horn start will be used.
- Schedule/  
Warm-ups:** Saturday AM Session: Warm-ups 7:00-8:00 AM. Meet start 8:15 a.m..  
Saturday PM Session: Warm-ups will start immediately after the conclusion of the morning session and run for one hour. Estimated meet timeline will be posted on our web site at [www.swimswat.org](http://www.swimswat.org)  
Wednesday evening, December 2nd.
- Wisconsin Swimming warm-up procedures will be in effect. Morning sessions will have 30 minutes of circle swimming with no racing starts. **FEET FIRST THREE-POINT ENTRIES FROM THE STARTING END DURING GENERAL WARM-UPS WILL BE ENFORCED,** unless performing one way starts. The second 30 minutes, sprint lanes will be opened as needed. The afternoon sessions will use the same format. Violators of the Wisconsin Swimming warm-up procedures may be subject to disqualifications.
- Class of Meet:** Swim your own age high point meet. One class for 7 & Under and Senior.
- Format:** All events will be pre-seeded with the exception of the 13 & Over 400 IM which will be positive check-in and seeded on deck. Heats for the 400 IM will swim fastest to slowest, alternating Women & Men heats. Positive check in will close 30 minutes before scheduled meet start time. 8 & U individual events will be staged. A swimmer who crosses events between age group and Senior events, are only eligible for one high point award. Points will not be combined between age groups.
- Heats/events may be combined to stay within 4 hour rule, but will be awarded as separate age groups. All events are timed finals.
- Eligibility:** All swimmers must be currently registered with United States Swimming. Out of state entrants must present a valid 2009 USA-S card at the Scoring/Records Table prior to pool entry. Age up date is 12/5/09. Coaches must display current coaches card while on deck. Official 2009 USA Swimming and WI LSC rules shall prevail at this meet.
- Entry Limit:** Participation is limited to a **maximum of four (4) individual events per day**, plus relays. Age is to be determined as of December 5, 2009.
- Entry Fees:** \$4.00 per individual event. \$12.00 per relay. A \$3.00 splash fee (WI LSC Rule) must be paid for each swimmer entered in the meet. Entry fees must accompany entry forms. Recap statement must be complete and the waiver form signed. Money used for reservations is nonrefundable, and cannot be used to offset cost of relays, deck seeding or splash fees.  
**Checks should be made payable to SOUTHWEST AQUATIC TEAM.**
- Deck Entries:** The entry fee for deck entries will be \$8.00 (\$16.00 for relays). Deck entries will be allowed at the discretion of the meet director and only to fill open lanes if the time line permits. (Additional heats will not be added). Deck entries close 30 minutes prior to the start of the session.

**Entry Deadline:** Entries via hytek file must be emailed to Todd Roberts: **NO LATER than 6:00 pm on Friday, November 20, 2009.** Entries can be emailed to Todd Roberts: [troberts2@wi.rr.com](mailto:troberts2@wi.rr.com). Completed recap forms, waivers, fees and hard copy of your team entries must be mailed and received by Cindy Budnik by Wednesday, November 25.

**Disabled Swimmers:** Coaches are encouraged to inform officials and the Meet Director of any special needs swimmer during warm-ups.

**Deck Seeded Events:** The 400 IM will be deck seeded. Entries may be limited by Meet Management to adhere to the four (4) hour session rule. Accepted entries will be posted on the SWAT website on Monday evening, November 24. Swimmers cut from these events by meet management will be refunded their entry fee or that fee can be used to deck seed in an open lane of another event. Positive check in for these events will be located at the Scoring/Records Table. Positive check in will close 30 minutes before the start of the session.

**Relay Cards:** Relay cards will be in the coach's packet. Cards must list the swimmers' last and first names (names must be listed in order of swim) and the ages of the swimmers.

**Coaches Packet:** Coaches may pick up their packets at the Scoring/Records Table. **Any monies owed must be paid before you can obtain your packet.** Please be prepared to show your U.S.A.S. coach's card at the time you pick up your team packet. **Coach's cards must be visible at all times on deck.**

**Awards:** Senior Events –No Awards  
Ribbons – 1st – 16<sup>th</sup> - for 13 and under swimmers (Individual events)  
Relay events 1<sup>st</sup> – 6<sup>th</sup> Ribbons (12 and under relays)

**High Point Awards:**1<sup>st</sup> – 12<sup>th</sup> for each single age group (7 & U,8, 9, 10, 11, 12, 13, )  
**Awards must be picked up at the meet. Awards will not be mailed after the conclusion of the meet.**

**Heat Sheets:** Admission: \$4.00 per day for spectators over 12 years. Heat Sheets: \$2.00

**Food:** Food and beverages will be available on the premises. No food or beverage is allowed in the pool area.  
**Swim Supplies:** *All-American Aquatics* will be on site Saturday to provide swim accessories and supplies.

**Conduct:** Each team is responsible for the conduct of its swimmers. In compliance with the Video Prevention Act the use of any recording devices is prohibited in the locker rooms.  
  
Meet Marshals shall have the authority to remove any swimmer/s from the meet for any violation such as improper behavior damage to property, etc. Such teams are responsible financially for damage of property. There shall be No Smoking permitted at any time on the premises. **Please make sure your team's area on deck and rest area is picked up at the end of each session.**

**First Aid:** Injuries must be reported to the Lifeguard AND to the Meet Director. A first aid kit will be located at the Lifeguard station.

**Lost & Found:** An area for lost and found will be located by the concessions. After the meet contact Cindy Budnik, at 262-679-7928.
