National Certification Requirements

1. Applicant must:
 - A. Be a current member of USA Swimming; certification will **not** be issued and application fees will **not** be refunded to non-member applicants;
 - B. Be a currently certified LSC official **for at least one year** in an equal or higher capacity than the position for which certification is requested;
 - C. Attend officials briefing sessions and officiate at a meet *approved* by the USA Swimming Officials' Committee;
 - D. Have performed satisfactorily, in the opinion of the Meet Referee and/or Chief Judge, the functions of the position requested at a minimum of **three** meet sessions.

2. **Instructions**
 - A. Fill out the application form completely;
 - B. Certification portion of the form **must** be signed by the Meet Referee or Chief Judge of the approved meet;
 - C. Make check payable to USA SWIMMING, and submit with application to the Meet Referee or Chief Judge for transmittal to USA Swimming.
