<b>LOCATION</b>	<b>APEX Aquatics Center, Lehman College</b> <b>250 Bedford Park Boulevard</b> <b>West Bronx, NY 10468</b>
<b>FACILITY</b>	<b>8 lanes x 25 yards competition course with Daktronics timing system and scoreboard.</b> Pool has <b>not</b> been certified in accordance with Article 104.2.2C (4). Water depth from end of pool in shallow end is: 13' at 1 meter / 12' at 5 meters Water depth from end of pool in deep end is: 7' at 1 meter / 7' at 5 meters
<b>SESSIONS</b>	<b>Saturday, November 2 – Age Group Session – 8:00 AM Warm Up / 9:00 AM Start</b> <b>Saturday, November 2 – Senior Session – 1:00 PM Warm Up / 2:00 PM Start</b> <b>Sunday, November 3 – Age Group Session – 8:00 AM Warm Up / 9:00 AM Start</b> <b>Sunday, November 3 – Senior Session – 1:00 PM Warm Up / 2:00 PM Start</b>
<b>FORMAT</b>	<b>Timed finals. Deck seeding will be used. To safeguard the timeline, 8&amp;U athletes may only swim 50 Yard events and 100 Yard Free/100 Yard Individual Medley.</b>
<b>ELIGIBILITY</b>	Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers. All swimmers participating in this meet must be registered by the first day of the meet. Age on <b>November 2, 2019</b> will determine age for the entire meet.
<b>DISABILITY SWIMMERS</b>	Swimmers with disabilities are encouraged to attend. Contact the Meet Director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition.
<b>ENTRIES</b>	<b>Swimmers may enter up to 4 events per session. <b>DEADLINES AND PROCEDURES</b>	<p>Metro LSC Team entries must be received by <b>October 11, 2019</b> to be given preference over non-Metro LSC Teams. Entries will be processed as received in a first-come/first-served fashion. Non-Metro LSC Team entries must be received by <b>October 18, 2019</b> and will be processed as received after the Metro LSC deadline.</p> <p>An email confirming receipt of entries will be sent if you provide an email contact. <b>TIME TRIALS</b>	Time Trials will not be available at this meet.
<b>ENTRY FEES</b>	<p><b>Entry Fee -- \$5.00 per individual event must accompany the entries.</b></p> <p>Make check payable to: <b>Innovative Aquatics</b></p> <p>Payment must be received by <b>October 18, 2016</b> for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.</p>
<b>WARM-UP</b>	<b>General Warm Up</b>
<b>SCRATCHES</b>	<p>Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than 30 minutes prior to the start of each session.</p> <p>Coaches are asked to clearly indicate entire session and individual event scratches.</p>
<b>COACHES</b>	In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.
<b>AWARDS</b>	<b>Ribbons for 1<sup>st</sup>-8<sup>th</sup> in the 10&amp;U, 11-12 divisions – no awards for 13&amp;O.</b>

<b>RULES</b>	USA Swimming Rules and Regulations will apply. <b>The USA Swimming Code of Conduct is in effect for the duration of the meet.</b> The overhead start procedure may be used at the discretion of the Meet Referee

<b>SAFETY</b>	<b>All swimmers must wear footwear upon leaving the pool area.</b> Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. <b>“Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer’s legal guardian, to ensure compliance with this requirement”</b>
<b>MAAPP POLICY:</b>	<b>All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.</b>
<b>DISCLAIMER</b>	It is understood that USA Swimming, Inc., Metropolitan Swimming, Inc., Trident Aquatic Club, New York City Aquatic Club and JUST In Timing shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
<b>DECK CHANGING</b>	Deck changes are prohibited.
<b>AUDIO/VISUAL AND DRONE STATEMENT</b>	Use of audio or visual recording devices, including a cell phone, is not permitted in the changing areas, restrooms, locker rooms or behind the blocks. Operation of a drone or any other flying apparatus is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
<b>PHOTOGRAPHIC POLICY</b>	Any photographer or videographer, who intends to take pictures at a Metropolitan Swimming Sanctioned meet, must complete and submit a Photographer Registration Form to the Meet Director before commencing Activity. Forms are available on the Metropolitan Swimming website as Well as from the Meet Director.

<b>DIRECTIONS</b>	<b>250 Bedford Park Boulevard West (between Goulden and Paul Avenues).</b>  <b>BY SUBWAY:</b> Take the IRT #4 (Lexington) or IND ‘D’ to Bedford Park Boulevard and walk West on Bedford Park Blvd past Paul Ave to entrance on south side of street.

**BY CAR:** Take Major Deegan Expressway (I-87) to the Van Cortlandt Park South Exit. Go left onto Van Cortlandt Ave. Proceed to Sedgwick Ave. Make left onto Sedgwick. Turn right at Goulden Ave and go to Bedford Park Blvd. Proceed two long blocks. Parking lots will be on right.

Via Saw Mill River Parkway South (becomes Henry Hudson Parkway) to Mosholu Parkway exit. At the second traffic light turn right onto Paul Ave. Go two blocks. At Bedford Park Boulevard turn right. APEX building is on left. Proceed to traffic light; turn left onto Goulden. Parking lot is on the right.
