## 2022 Dues amounts are as follows:

- Single Membership - \$530 - Single** membership is an adult individual with no dependents or spouse (i.e. ONE PERSON)
- Senior Membership - \$545 - Senior** membership is a **married couple** that is 65 years old or older with no dependents residing in the same dwelling.
- Family Membership - \$700 - A family unit** is defined as a parent\spouse and children whose permanent residence is in the same dwelling up to SIX family members. Any extended family residing in the SAME RESIDENCE on a permanent basis with verification may be added to the membership for an additional fee of \$50 per person.

## Options

1. Payment of full yearly membership by April 1st- Receive 8 one-day guest credits (COVID Permitting), No late fee.
2. Payment of 50% yearly membership by April 1st and remaining 50% by May 1st - Receive 4 one-day guest credits (COVID permitting), No late fee.
3. Payment of yearly membership received in full or postmarked between May 2nd to May 31st - No guest credits, No late fee.
4. Payments received or postmarked on or after June 1st – will be assessed \$25.00 late fee.

## Bond

1. New members – first year member – bond is not due but may be paid
2. First year full time members – Bond of \$400 may be paid in full or 50% over two years
3. Second year members – if you have not paid full bond, the final payment is due
4. Full time members – bond must be paid in full

Please note that all family members and guests must abide by all Pool Rules and Regulations for Georgetown. Members will be responsible for their guests. **Please fill out one form and return, having executed BOTH SIDES.** Please retain the other for your records.

THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS*

In consideration for being permitted the right to enter and use the swimming pool facilities operated by Georgetown Swim Club, Inc., a non-profit ("Georgetown") including the land, pool, buildings, recreational equipment and all other real and personal property thereon ("Swimming Pool Facilities"), I, on behalf of myself and as the parent or guardian of the family members listed on the "2021 Membership Data" form incorporated herein; as well as for our heirs, executors, administrators, successors and assigns **RELEASE AND DISCHARGE** Georgetown and its Board of Trustees, officers and directors, trustees, agents, managers, and employees from and against any and all liability for personal injuries, death and property damage sustained by myself and/or the child(ren) identified above which in any way arises out of or is connected with my/our entry onto and use of the Swimming Pool Facilities.

I, on behalf of myself and for the child(ren) identified above accept and assume any and all risks and liability for injuries, death and damages in any way arising out of or in connection with my/our entry onto and use of the Swimming Pool Facilities.

**I, on behalf of myself and for the child(ren) identified above, agree to INDEMNIFY, DEFEND AND HOLD HARMLESS, to the fullest extent permitted by law, Georgetown and its Board of Trustees, officers and directors, trustees, agents, managers, and employees from and against any and all claims, losses, judgments, suits, damages, liabilities, costs, attorney's fees, and expenses of any kind or nature ("Claims and Losses") in any way arising out of or in connection with my/our entry onto and use of the Swimming Pool Facilities including, but not limited to, Claims and Losses caused by the fault and/or negligence of Georgetown and its Board of Trustees, officers and directors, trustees, agents, managers, and employees.**

I agree to supervise all of my children and guests and ensure that they comply with all Georgetown Rules and Regulations. I accept full responsibility for the conduct and safety of all my children and guests who enter and use the Swimming Pool Facilities.

I, on behalf of myself and for the child(ren) identified above agree that this Release, Indemnification and Hold Harmless Agreement is intended to be as broad and inclusive as permitted by the laws of the State of New Jersey and that if any provision of this Agreement is determined to be contrary to law, invalid or otherwise unenforceable, the offending provision shall be disregarded and the remainder of this Agreement shall remain in full force and effect and be enforced as if the offending provision had never been included.
