In addition to the information provided in the Meet Announcement, listed below, the option for entering Time Trials will also be available on OME, beginning at 5:30 pm on Wednesday, March 20th, following the General Meeting.

- Time Trials will be conducted on a time-available basis and are limited to approximately one hour.
- Time Trials will be held under a separate sanction of Arizona Swimming, Inc.
- Each time trial swum will count toward the daily event limit with a combination of time trials and individual meet events not to exceed three (3) per day. A swimmer is limited to three (3) time trials during the course of the meet.
- Time Trials will be available on OME (see below) and deck-entered at the Clerk of Course. Time Trials entries will close when the maximum allowable time has been reached or one hour before the scheduled end of that day's preliminaries, whichever comes first.
- Time Trial Entry Fees: \$17.00 per individual event *** \$39.00 per relay event
- Time Trials shall be swum in the order listed under the meet program, with the following exception: The 1000 and 1650 Freestyle Events will only be offered on one day. The Meet Referee will determine the day based on the size of the meet and available time and will announce the day at the General Meeting.

Order of Time Trial Events
Day 1: Day 1 events except 1000, Day 2 events, Day 3 events, Day 4 except 1650
Day 2: Day 2 events, Day 3 events, Day 4 except 1650, Day 1 events except 1000
Day 3: Day 3 events, Day 4 events except 1650, Day 1 events except 1000, Day 2 events
Day 4: Day 4 events except 1650, Day 1 events except 1000, Day 2 events, Day 3 events

ENTERING TIME TRIALS ON OME

1. Each day's Time Trials are listed separately on OME, eg. **2019 4C SPEEDO SECTIONALS-TIME TRIALS: THU MAR 21**
2. Entries on OME will be by credit card only.
3. **Thursday's Time Trials will open on OME on Wednesday, March 20th at 5:30 pm and remain open until 5:59 AM, Thursday, March 21, or until the OME cap of 65 athletes is reached, whichever comes first.**
4. Thursday's Time Trials **will re-open for additional on-deck entries at 8:30 am**, and will remain open, based on available lane space, until the maximum allowable time has been reached or one hour before the scheduled end of that day's preliminaries, whichever comes first.
5. Time Trials for Friday, Saturday, and Sunday will open **on OME** at 1:00 pm of the preceding day (eg 1:00 pm Thursday for Friday's Time Trials) and will remain open until 5:59 am on the morning of that day's Time Trials, or until the OME cap of 65 athletes is reached, whichever comes first.

Entries will re-open on-deck at 8:30 am, and will remain open based on available lane space, until the maximum allowable time has been reached, or one hour before the scheduled end of that day's preliminaries, whichever comes first.

6. The 1000Y & 1650Y Freestyles, and relay entries will not be available on OME. These events will remain as deck-seeded events. The 1000Y & 1650Y Freestyles will be offered based on the size of the meet and available time and will be announced at the General Meeting.
