Course: Outdoor 10 lane, 25 Yard course, with non-turbulent lane dividers, automatic Colorado start and timing system. Continuous warm-up will be available throughout the meet.

Eligibility: This is a closed invitational meet open to athletes holding a current USA Swimming registration, and is a member of MAC-AZ, SANTA FE SEALS, RACE-NM, BHC-NM, SOCAL, NOVA-CA, MVN-SCS, SAND-CA, RMDA-SCS, LCAT, DUKE CITY. Athletes who are eligible to attend the AZSI Age Group Classic Championship meet are ineligible to participate.

Meet Rules:

1. This is an ABC meet. NTS with the exception of events 19/20, 29/30
2. Swimmers may enter with a SCY, LCM, SCM or NT entry time, but no converted times may be used.
3. No Time Trials will be offered
4. For the safety of all swimmers, coaches, and meet personnel, all policies and procedures related to social distancing must be followed by all individuals at the meet. All information will be emailed to participants. This meet is limited to 350 swimmers with no more than 150 people (including swimmers, coaches, officials & volunteers) on the pool area per meet session.
5. Swimmers are limited to Three (3) events per session/per day, Nine (9) events for the meet.

6. This will be a CLOSED DECK MEET. Only swimmers (entered in the session), coaches, officials/meet admin, timers and pool staff will be permitted on the pool deck. All spectators may view the meet from outside the pool fence. Per Safe Sport guidelines, parents will have visual contact with their swimmers during the meet.
7. Masks are required by all swimmers, coaches, and all meet staff upon entering the facility. Per the city of Mesa ordinances, individuals without a mask will not be permitted inside of the facility.
8. MAC has taken enhanced health and safety measures for all those involved in this event. Individuals must follow all posted instructions. An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and guests with underlying medical conditions are especially vulnerable. By visiting the Kino Aquatics Pools and MAC 2021 Swim Spectacular meet, individuals voluntarily assume all risks related to exposure to COVID-19.
9. All swimmers must enter thru the Gates by the MAC Offices and exit through the Northeast gates. Restrooms will only be available for emergencies, No showers or changing is allowed. Lobby will remain closed.
10. We may need to limit heats due to timeline restrictions, Coaches will be advised.
11. There will be positive check in on events 19/20 & 29/30

Rules Governing Sanctioned Meets

1. Age on the first day the meet will govern for the entire meet.
2. Conduct of the sanctioned event shall conform in every respect to all technical and administrative rules of USA Swimming and the Minor Athlete Abuse Prevention Policy ("MAAPP").
3. Swimming competitions shall be conducted in conformance with USA Swimming Technical Rules.
4. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
5. The competition course **has been** certified in accordance with 104.2.2C(4) as to pool length. A copy of such certification is on file with USA Swimming
6. The minimum water depth, measured in accordance with Article 103.2.3, is 7 feet, 6 inches at the start end and 6 feet, 7 inches at the turn end.
7. Deck changes are prohibited.
8. The Arizona Swimming Controlled Meet Warm-up and Safety Guidelines will be posted and enforced.
9. No swimmer will be permitted to compete unless swimmer is a member of USA Swimming. On deck registration is not available at any Arizona Swimming meet.
10. The use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, restrooms, locker rooms or other areas as may be designated by the Meet Director/Meet Referee.
11. All referees, starters, administrative officials, chief judges and stroke and turn judges serving in an official capacity in a sanctioned event must be non-athlete members of USA Swimming or members of other FINA member organizations. All meet directors for meets sanctioned by USA Swimming must be members of USA Swimming. Except for coaches accompanying athletes participating under the provisions of 202.9 or USA Swimming's "open border" policy, all persons acting in any coaching capacity in a sanctioned event must be a coach member of USA Swimming.
12. Officials and Meet Marshals must sign in and present proof of current membership and/or training respectively, to the Meet Referee prior to the start of each session of competition. If requested, Arizona Officials and Meet Marshals must present their AzSI issued Picture ID's to the Meet Referee
13. Coaches must sign in and present proof of current membership at the Clerk of Course prior to the start of each session of competition. If requested, Arizona Coaches must present their AzSI issued Picture ID's to the Clerk of Course. Deck Pass will be accepted as proof of current membership with an accompanying photo ID.
14. All Officials, Coaches and Meet Marshals shall display their valid Arizona Swimming Picture ID badge in a visible manner at all times. Meet Marshal's shall wear their identifying vests.
15. Swimmers with a disability are welcome. The Swimmer (or swimmer's coach) is responsible for notifying the Referee, prior to the competition, of any disability of the swimmer and of the requested modification. The swimmer/coach shall provide any assistant(s) or equipment (tappers, deck mats, etc.) if required.
16. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Session 2 March 13 Warm-up: 11:00 am or 20 minutes after the morning meet, Meet Start: 60 minutes after the start of warm-up

Session 3 March 14 Warm-up: 11:00 am or 20 minutes after the morning meet, Meet Start: 60 minutes after the start of warm-up

Lane assignments for the warm-up/cool down pool will be made. Timelines will be provided once available.
