Waiver and Release of Liability

Please read carefully before signing. Please complete one form per family. In consideration of my child(ren) being allowed to participate in any way in the South West Aquatic Team (SWAT) program, related events and activities, the undersigned acknowledges, appreciates and agrees that:

1. Although South West Aquatic Team (SWAT) rules, equipment, training and discipline are designed to avoid any injury, the risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death.

2. On behalf of my child(ren) and for myself, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, arising out of, related to and resulting from participation in this program, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of the South West Aquatic Team (SWAT), their officers, officials, agents and/or volunteers, other participants, sponsoring agencies, sponsors, advertisers, Border Champs, and if applicable, owners and leasers of premises used to conduct the event (RELEASEES) or others, and assume full responsibility for my children(s) participation to the fullest extent of the law.
