WAIVER 2019-2020

Consent Waiver - I/we, the parents/guardians of the above named swimmer(s), hereby consent to his/her participation in any or all of the Collingwood Clippers Swim Club activities and assume all risks of injury to our child arising there from. In consideration of our child being accepted as a member of the Swim Club, we agree that there shall be no liability on the part of the coaches, the Swim Club, Clippers Swimming, participants or persons transporting our child to and from activities and we hereby waive and release the Collingwood Clippers Swim Club from any/all claims which we may have in connection with any such injury.

Media Waiver - I/we, the parents/guardians of the above named swimmer(s), hereby consent to he/she being showcased for an achievement or other event related to the swim club whenever possible. There may be occasions during the swim season when your swimmer(s) will be photographed participating in a club related event (swim practice, swim meet, club event, etc). Photographs of swimmers may be used on our website, articles submitted to news papers regarding the Collingwood Clippers, club news letters and on approved swim club social media.

Personal Information Protection & Electronic Documents Act - I/we, the parents/guardians of the above named swimmer(s), hereby give permission to the Collingwood Clippers Swim Club to enter required personal information on the Team Unify database for the purposes outlined in Swim Ontario's policies, which I have read. I understand that I may withdraw consent at any time upon written notice to the Swim Ontario Executive Director, and my personal information will be purged from the database. Withdrawal constitutes de-registration. The club will be informed immediately upon the receipt of the written notice.

Fees and Payments – The fee to swim for CCSC is a fee which includes taxes, pool fees, coach and operational costs. If workouts are changed in any way or cancelled there will be no reimbursement of fees or added workouts. The fee to swim includes holiday days and time off. The costs below are broken down so families can pay monthly. Please understand this before you agree to this waiver and commit to joining. Please note that the Collingwood Clippers Swim Club will now only be using credit card for online payments. This is to simplify the billing process and has also allowed us to split our club fees over 9 months (October to June). Payments will be processed on the 1st of each month. There will be a 3.65% plus 0.20 (cent) charge on each transaction.

- 1) **Swim Ontario fee, SNC fee & Wine Raffle (non-refundable)**: Payment for the Swim Ontario fee, SNC fee and Wine Raffle will be added to the first instalment payment from when your swimmer starts.
- 2) **Swim meet fees**: Will be communicated to each family and are reflective of the number events in which your swimmer participates in addition to any coaching cost (if applicable).

- 3) **Club Fundraising:** Each family is expected to pay \$100.00 at the start of the swim season for the clubs wine raffle fundraiser. In years past families have had to donate wine bottles, moving forward wine will be provided by the swim club. We hold the wine raffle at our June Swim Meet and all families will be provided with 8 Raffle Tickets in May. Families then have two options; sell the tickets to friends/family and keep the money, or enter your name on the tickets and join in the raffle.
- 4) **Volunteer Bond Hours:** Each family is expected to pay a post-dated bond cheque of \$150.00 + \$50.00 per additional swimmer to a maximum of \$250.00. The cheque needs to be dated for June 1st, 2019 and will only be cashed in the event that your bond hours are not fulfilled by the end of the swim season. Each family is expected to complete a minimum of 10 bond hours. Families can work off these bond hours by volunteering at approved CCSC events. Please submit bond cheques to our Treasurer by way of the locked black box in the pool foyer.
- 5) **Swim-a-thon:** Each swimmer is strongly encouraged to participate in our yearly Swim-a-thon (date TBD each season). This event serves as a fundraiser with 10% of funds going towards Swim Ontario and the remainder going to the maintenance and replenishment of Club. We ask each swimmer to raise \$100.00 for Swim-a-thon.

Discontinuation of Swimming – CCSC’s swim season is essentially split into two swimming blocks (October 1st - January 31st & February 1st - June 30th) to reflect short course and long course swimming. If families wish for their swimmer(s) to discontinue swimming with the Collingwood Clippers Swim Club written notice must be submitted to the club Registrar & Treasurer. Families are responsible for payments remaining within that swimming block. Example: if your swimmer no longer wishes to swim past the month of January, you must give written notice within the month of January or prior. If your written notice is received after February 1st (into 2nd swimming block), you would then be responsible for the remaining payments until the end of the swim season.

Code of Conduct – Members must abide by the CCSC Team Manual policies in order to remain a member in good standing. Policies are subject to change with notice given.
