

COACH NOTES FOR 2021 WESTERN ZONE SENIOR CHAMPIONSHIP

- **Distance (and Relays) will be run SCRATCH ONLY**
(NO positive check in required).
- **Scratches (electronic)** will close 15 minutes after General Meeting for Tuesday distance events. Please email Tuesday distance scratches to Gloria Schuldt at gloria_schuldt@att.net or text 469-426-2850. **Finals scratches at Admin Office ONLY**
- **Swim Offs IF swimmers are at different pools will be at 4:50 PM at North**
- **Early heats** of Tuesday distance will be run **slow to fast** alternating Women and Men starting at 11:00 AM. Final six heats (5 PM at North) will be swum slow to fast alternating Women and Men.
 - General warm up will be available at North from 7-10:00. Specific warm up for Tuesday distance swimmers will be available at West and North from 10:00-11:00 (clear pools 10:50)
 - Tuesday at conclusion of Early heats at Clovis West, pool will be open for general warm up rest of day for arriving teams.

FINAL 6 HEATS SLOW TO FAST ALTERNATING AT NORTH 5:00

- **Morning Relay Option** must be declared by scratch deadline for that day. Relay names will be due at 10:00 AM day of the relay. Relay names for Finals' relays are due at start of Finals (6 Wednesday-Friday and 5 on Saturday).
Reminder: ALL "C" relays are morning relays & there are no "C" 800 free relays.
- **PRELIMINARY SESSIONS WILL START AT 8:30 AM**
Wednesday through Saturday. Two Warm up sessions: Session 1 7:00-7:40 AM; Session 2 7:40-8:20
- **Group A** will start the meet at North (early heats Tuesday, prelims Wednesday/Thursday) – There are TWO warm up groups: A-1 and A-2. See warm up schedule
Group B will start the meet at West (early heats Tuesday, prelims Wednesday/Thursday) - There are TWO warm up groups: B-1 and B-2. See warm up schedule
