

CUDA COVID-19 Waiver

1. The novel coronavirus, hereinafter referred to as “COVID-19”, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to be spread mainly from person-to-person contact. I understand COVID-19 has a long incubation period during which carriers of the virus may not show symptoms, yet are still highly contagious. Given the current limitations and availability in COVID-19 viral testing, it is impossible to identify those who have COVID-19 and those who do not.

2. Risk of transmission: I understand that due to the frequency of practices, participation by other teammates in practice, participation by other use groups at the same facility, and the characteristics of the virus, Front Range Barracudas cannot guarantee that the undersigned or the participant will not become infected with COVID-19. Further, attending practice could increase your risk and the risk of the participant of contacting COVID-19, even though standard precautions are being observed.

3. I am unaware of my child being a possible carrier and/or infected with COVID-19: I confirm that my child **has not** tested positive for COVID-19 in the last 30 days and that he/she is not presenting with any of the following COVID-19 symptoms o:

- A. Fever of 100.5 degrees Fahrenheit or 37 degrees Celsius or higher
- B. Shortness of breath
- C. Dry cough
- D. Runny nose
- E. Sore throat
- F. Diminished sense of taste or smell

4. Contact with infected: I confirm that my child has not knowingly been in close contact with someone who has tested positive for COVID-19 in the last 14 days, or with anyone that has had the symptoms identified in paragraph 3 in the last 14 days. Close contact is defined as 6 feet or less for a duration of fifteen minutes or more.

5. Public travel: I confirm that my child has not traveled outside of the United States in the past 14 days. I confirm that my child has not traveled domestically by commercial airline, bus, or train within the last 14 days.

6. Those with underlying health issues or in high risk categories, are returning to practice at their own risk.

Acknowledgment and Assumption of Risk

The undersigned parent and/or legal guardian does hereby acknowledge that he/she is aware of the dangers and the risks to the participant's person and property involved in participating in practices with Front Range Barracudas.

I will counsel my child so he/she understands that it is important for his/her safety and the safety of others, to follow all instructions of the coaches and staff regarding social distancing procedures. I agree that I am responsible for my child's conduct while he/she is participating in a Front Range Barracudas-sponsored activity.

I also understand that there are potential risks that are unknown to all parties at this time. Due to the dangers of participating in this activity, the participant and the undersigned parent and/or legal guardian, recognize the importance of fully complying with the applicable laws, policies, rules, regulations and instructions issued by the supervisors regarding participation in this activity. By signing this waiver, all parties agree to full compliance with these terms.

The undersigned parent and/or legal guardian acknowledge that the participant voluntarily elects to participate in this activity, with knowledge of the risk involved, and hereby agrees to accept and assume any and all health risks related to COVID-19.

Waiver of Liability and Indemnification:

In consideration for being allowed to voluntarily participate in the above-referenced activity, on behalf of myself, the participant, his/her personal representatives, heirs, next of kin, successors and assigns, the undersigned parent and/or legal guardian forever: a) waives, releases, and discharges Front Range Barracudas and its employees and the Board of all liability for the participant's death, disability, personal injury, or claims of any nature related to COVID-19, which may hereafter accrue to the participant, and the participant's estate as a direct or indirect result of participation in the activity; and b) defend, indemnify, and hold harmless Front Range Barracudas, its employees and the Board, from and against any and all claims of any nature related to COVID-19 including all costs, expenses and attorneys' fees, which in any manner result from participating in a team-sponsored activity.
