Any vacancies created as a result of the Board’s removal of such will be then appointed by the General Chair, with the approval of the Board, until a subsequent election is held at the next regularly scheduled Indiana Swimming House of Delegates Meeting. Board members with extenuating circumstances that prohibit them from fulfilling these requirements may send an appeal to the General Chair to ask for an exception to removal from office.

Proposal: Outreach Qualification Guidelines

OUTREACH membership is an option available for lower-income members to reduce the annual membership fee to \$7.

The following documentation is acceptable as proof for outreach fees and needs to be submitted to IN Swimming with registration fees/files/reports:

1. **Free or Reduced school lunch program documentation**
School letter sent home to family upon school corporation application process or email from school administration is acceptable
2. **Hoosier Healthwise Insurance card copy**
3. **WIC card copy**
4. **Other forms accepted if presented and would be equivalent to above**

Please submit these kids as a Full (year-round) membership with your TM registration file. Outreach members are full members- N in Team Manager. In the text of your email, please indicate that you are sending in "Susie Smith" as Outreach. Documentation above can be submitted with Registration Fee Summary Form and payment. You cannot revise a previously submitted outreach application, so be sure you have this documentation before you send in an outreach registration.
