Facility: 25 yard, 8 lane indoor pool with 8 starting blocks and competitor non-turbulent lane lines, and an addition 5 lane 20 yard pool warm-up/warm-down separated by a bulk head

Parking: There is limited parking directly in front of the pool, cars may be parked on Chopin Street or side neighborhood streets, or in the parking lot on Essex and Dougherty Ferry Drive.

Warm ups: Wednesday PM:

MEET STARTS AT 6:30 pm

There will be a short break after events 12, 24, and 34, decided upon at the meet.

Warm Up Procedure

Warm-up lanes will be open to all swimmers attending. The host team reserves the right to extend or change the warm up period for safety considerations. Warm up procedure will be defined by Ozark LSC regulations and USMS regulations.

Eligibility

Entries limited to currently registered USA swimmers. USA Swimming memberships applied for will not be accepted. Ozark swimmers' registration will be checked at the registration table. Swimmers registered in other LSCs must provide proof of registration. Teams will incur a \$100 fine for each non-registered swimmer entered. Any swimmer found not to have a current USA Swimming membership who swims in an Ozark sanctioned meet, and/ or the team is subject to a \$100 fine per swim.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member coach, it is the responsibility of the swimmer or the swimmers legal guardian to ensure compliance of this request.

All coaches must hold a valid USA Swimming Coaches Card and all officials must be USA certified.

Entries

Hytek/Team Unify meet entries will be accepted prior to noon on Wednesday November 8, 2017. After that all entries must be deck entries submitted on Wednesday, November 8, 2017 from 5:30pm – 6:20pm. Swimmers and/or their representative will fill out entry cards with the following information: Name, Age, USA Swimming number, Club and Event number. There will not be any additional charge for deck entries. Deck entries will not be seeded with advanced entries and will be added in available lanes and/or additional heats.

All swimmers are limited to 4 individual events.

FEES for USA Swimmers:
\$3.00 per individual event
\$7.00 swimmer surcharge

Competition Rules

The 2017 USA Swimming/ Ozark Swimming official rules and the 2017 USMS Swimming rules shall govern the meet as applicable, and all technical and administrative rules of USA Swimming will apply. Swimmers age as of November 12, 2017 shall determine age for the entire meet.

Safety

Possessing a still or video camera or a cell or video phone is absolutely prohibited in all dressing areas, locker rooms, bathrooms, or any other locations where swimmers may be dressing. Any person so found possessing such devices in these areas will immediately be expelled from the meet with all fees forfeited, and subject to further Ozark LSC and/ or USA Swimming sanctions and penalties.

Swim Suits

The only suits allowed are those permitted by FINA and in compliance with current USA Swimming rules. The USA Swimming Rule, accepted by the Ozark Swimming House of Delegates, will be in effect. It reads as follows:

102.9 SWIMWEAR

1. Design

- A. Swimsuits worn for all 12 and under group defined competition shall not cover the neck, extend past the shoulder, nor past the knee.
- B. Swimsuits worn for competition must be non-transparent and conform to the current concept of appropriate.
- C. The Referee shall have the authority to bar offenders from the competition until they comply with the rule.
