CLASSIFICATION: A-BB-B-C

FACILITY: Six 7 foot lanes, 25 yards, standard gutters, pool depth of 3 feet 6 inches at the shallow end and 10 at the deep end; nonturbulent lane markers, backstroke flags, and 30-inch Paragon quick start slanted starting blocks at the deep end.

WARM-UPS The first 30 minutes will be circle swim. No diving into the pool. Enter pool feet first. Lane 1 is reserved for 8 and under. For the second half hour, lanes 2, 3, 4, and 5 will be for sprints with diving allowed. Swimmers must exit from the shallow end. Lane 6 will continue as circle swim. Officials will be on deck during warm-ups with authority to disqualify swimmers not following warm-up procedures.

TIMING SYSTEM: Colorado electronic timing system with strobe/horn start, touch pads and manual back-up timing buttons. Each lane will have two timers with electronic stop watches. All events will be timed finals.

ENTRY LIMIT: Each Swimmer is allowed to enter 4 individual events and 2 relays. Meet is limited to the first 1200 entries. Reservations must be accompanied by checks for the number of swims to be reserved. No refunds will be given.

OFFICIAL RULES: Official 1999 USS and Wisconsin Swimming Short Course Rules shall govern this meet. Relays: first and last names and swimmer ID of the competing swimmers and the order of swimming must be listed on the card prior to the relay. Ages as of 1/29/2000.

AWARDS: Awards for relay events will consist of ribbons for 1st - 6th place. Awards for individual events will consist of medals for 1st - 3rd and ribbons for 4th - 6th place. Heat winners for 8&U and 10&U will receive ribbons. Awards will not be mailed.

ENTRY DEADLINE: Completed entry forms and waivers must be received by the Meet Director no later than Wednesday, **January 19, 2000**. Do not send seed cards. The meet will be seeded using Meet Manager. Electronic copies via HY-TEK Commlink are encouraged. Please send hard copy with disk. Use separate entry form for male and female swimmers. Mail entries to Meet Director (address given above).

AGE GROUP: 8&U, 10&U, 11-12, 13-14, Senior.

SEEDING: This is a pre-seeded meet. It is the swimmer's responsibility to be at the blocks at the start of his or her event. There will be a Clerk of Course for 8&U swimmers. No deck registrations/entries will be accepted.

ADMISSION: There will be no admission charge. Heat sheets will be available at \$4.00 each.

FOOD: A large selection of food, beverages, and snacks will be available at reasonable prices throughout the day in the High School cafeteria.

MEET CONDUCT: It is expected that each club will be responsible for the conduct of their swimmers. If, in the opinion of the Meet Director/Marshall a swimmer's or spectator's conduct is harmful or disruptive he/she will be asked to leave the pool area.

FINAL RESULTS: One copy of the meet's final results will be sent to each team's designated recipient.
