Morning Session

Warm up & Warm-up - 7:55 am  
Start: Start - 9:00 am

Warm-up schedule: First 30 minutes; Circle swim all lanes  
Last 30 minutes; Lanes 1,2, & 6 - Circle swim  
Lanes 3,4 & 5 - Sprints

Afternoon Session

Warm up & Warm-up - Starts immediately after morning  
Start session. Afternoon session starts 1 hour and  
5 minutes after morning session ends.

Warm-up schedule: First 30 minutes; Circle swim all lanes  
Last 30 minutes; Lanes 1,2, & 6 - Circle swim  
Lanes 3,4 & 5 - Sprints

Pool: Indoor 25 yard, rollout gutter pool, 3 ft. 6 in. at shallow end, 5 ft. at deep end and 3 ft. 6 in. - 5 ft. at starting blocks. Six, 7 ft. lanes with nonturbulant lane markers, back stroke flags and 18 in. slanted blocks. Ample bleacher seating available.

Timing: Colorado System 5, electronic timing system with touch pads, back-up timing, electronic horn start will be used. Two back-up watches per lane. Hy-Tek Meet Manager software will score meet.

Officials: TBD.

Official Rules: Current Short Course USS and Wisconsin Swimming rules shall govern the conduct of this meet. Swimmers must be registered Wisconsin USS swimmers. Ages as of October 23, 1999. No deck registrations/entries will accepted.

Entry Limit: 4 Events and 1 Relays. Meet is limited to the first 1200 entries. Reservations must be accompanied by checks for the number of swims you wish to reserve. No refunds will be given unless space can be filled with waiting list entries.

Entry Fees: Individual events \$2.00 Relays \$6.00  
There will also be a \$1.25 splash fee per swimmer entered in this meet. This fee is mandated by, collected for, and sent directly to Wisconsin Swimming Inc.

Clerk of Course: A Clerk of Course will be available for 8 & U swimmers.

Scratches: Coaches are asked to report all known scratches prior to the start of the meet. Swimmers who fail to report when their event is called will be scratched from that event.

Admission: No admission will be charged. Heat sheets will available for \$2.50.

Awards: Individual Events; Medals will be awarded to first through third place, ribbons will be awarded fourth through eighth place.  
Relays; Ribbons will be awarded to each swimmer of first through third place relay teams.

Entry Deadline: Completed forms and waiver must be received by the meet director no later than October 16th, 1999. Hy-Tek Comm-link disks are preferred. Do not send seed cards, meet will be seeded by Hy-Tek Meet Manager.

Age Groups: 8&U, 10&U, 11-12, 13-14, Senior/Open.

Final Results: One copy of the final results will be sent to each team represented. Comm-link disks will be returned to teams that submitted entries on floppy.

Concessions: A concession area will be available with a nutritious selection of food and beverages available during the meet.
