**Sanction #: WI2019-038S**

- Location:** Waunakee HS Pool, 100 School Dr., Waunakee, WI 53597
- Facility:** Eight lanes, 25 yards flush deck, non-turbulence lane dividers and backstroke flags, with 18" height starting blocks. Pool is 7.5 feet deep at the starting blocks and 3.5 feet deep at the non-starting end of the pool.  
**The Competition Course has not been certified in accordance with USA Swimming's Rule 104.2.2C(4).**  
**100 yard relays will have the 2<sup>nd</sup> and 4<sup>th</sup> leg of the relay start in the water.**
- Timing:** Colorado System 6 with backup watches. All events are timed finals. Computerized score board for all lanes.

There will be at least three certified USA Swimming Officials on deck at all times.
- Rules:** Current USA Swimming and Wisconsin LSC rules shall prevail for this meet. Swimmers must be registered with USA Swimming. Events/heats may be combined as directed by the Meet Referee during the meet and by Meet Director for pre-meet seeding. Breaks may be added if need is determined by Meet Referee.
- Check-ins:** Open 400 IM, Open 1000 Freestyle, Open 500 Freestyle will be positive check-in events. Check-in with clerk of course. Check-in will close 30 minutes prior to the start of the session in which the event is contested. Heats may be limited for these events. A swimmer who checks-in and fails to swim in his/her individual checked-in event is barred from his/her next individual event.  
**\*\*We are asking swimmers to provide at least one (1) timer for the 500 or 1000 Free event in which they are competing.**
- Warm-ups:** Saturday AM Session 1 warm-ups are 7:00-8:00 am with competition starting at 8:05 AM. A 10 minute warmup for the Saturday Session 2 (500 events) will begin immediately following the Sat. AM Session 1. Saturday PM warm-up for Session 3 will begin not sooner than 11:30am, or will begin as designated on the Warm up Assignment sheet.  
  
Sunday warm-ups are from 9:00am -10:00 AM with competition starting at 10:05 AM. A 10 minute warmup for the Sunday Session 5 (1000 events) will begin immediately following the Sunday Session 4.  
  
All lanes open for circle swim for the first 50 minutes; sprint lanes open for 10 minutes in 6 lanes, with the other lanes remaining open for circle swim. Team lane assignments will be available in the coaches' packets.  
"THREE POINT ENTRY" ONLY. Meet Marshals will be on deck during the entire warm-up, with the authority to recommend disqualification.

**Entries/Deadline:** Swimmers may compete in 4 individual events per day and 2 relays. All teams are requested to submit entries in the Hy-Tek CommLink format. Emailed **Hy-Tek Entries are due Wednesday, January 16, 2019**. You will receive an e-mail confirmation of your entry within 48 hours. If you have not received that confirmation, please email Sandy Kuecker at [sandy.kuecker@waunakeewave.org](mailto:sandy.kuecker@waunakeewave.org). A check for meet entry fees, a hard copy of the entry fee remittance, and signed waiver may be sent via standard mail. ***For entries NOT submitted by Hy-Tek CommLink; hard copy, waiver and fees, must be received by Tuesday, January 15, 2019.***

Please notify the meet director and meet referee for any special requirements for disabled swimmers on the entry form.

Entries may be limited by the Meet Director to adhere to USA-S's Rule 205.3.1(F), i.e. the four hour session rule for 12 & Under athletes. A meet timeline and psych sheet will be sent to the email address who submitted the entries prior to the meet.

**Entry Fees:** \$3.00 LSC splash fee per swimmer, \$5.00 per individual event, and \$12.00 per relay

**Deck Entries:** The entry fee for deck entries will be \$5.50 (\$15.00 for relays) in addition to the \$3.00 splash fee (\$12 for relays). Deck entries will be allowed to fill open lanes. No additional heats will be added. Deck seeding will close 30 minutes prior to the start of each session.

**Deck USAS Registration** WAUN will not accept deck USA-S registration. An unregistered swimmer may not compete.

**Age Groups:** 8 and under, 9-10, 11-12, 13-14, Open on Saturday, 10 & under, 11-12, Open on Sunday  
Age as of the first date of the meet.

Awards for relay events will consist of ribbons for 1<sup>st</sup>-8<sup>th</sup> place. Awards for individual events will consist of ribbons for 1<sup>st</sup>-16<sup>th</sup> place. Coaches will be permitted to pick up awards at the end of each session. Awards will not be mailed.

**Coaches:** All coaches can pick up their coaches packets at the timing table on the pool deck. **Any monies still owed must be paid before you can obtain your packet.** Please be prepared to show your current USA-S membership card at the time you pick up your packet. **Coaches USA-S membership cards must be visible at all times on deck.** Entry changes are due in writing to the clerk of course at the timing table on the pool deck 30 minutes prior to the start of each session.

**Admissions:** 11 and older: \$5.00 per session (Session 1, Session 3, Session 4); No charge for Sessions 2 (500 free) & 5 (1,000 free)  
10 and younger: Free

Heat sheets will be made available electronically for free prior to the meet.

**Concessions:** A large selection of food and drinks will be available throughout the day.

**Meet** Flyover starts will be used.

**Conduct:** All teams are responsible for the conduct of their swimmers. The Meet Director/Marshall, at his/her discretion, shall remove any swimmers or spectators who behave in a disruptive or disorderly manner.

In accordance with the Federal Video Voyeurism Prevention Act of 2004 - the use of camera phones or video recording devices in the locker rooms is prohibited.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.
