- Date:** Saturday, February 10 through Sunday February 11, 2018
- Place:** Walter Schroeder Aquatic Center, 9240 N. Green Bay Rd., Brown Deer, Wisconsin (414) 354-9622
- Warm-up/Start:** Saturday and Sunday AM: Warm-up 7:30-8:30 am. The meet will begin at 8:35 am.
Saturday and Sunday PM: Warm-up, Time to be announced, 45 minutes in south pool, 15 minutes in north Pool
Feet-first entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition. South pool will be available for warm-up and warm-down throughout the meet.
- Pool:** Two eight lane, 25 yard pools with non-turbulent lane markers and backstroke flags. Pool depth at North pool starting end is 7'. Block height is 29.5". All competition will be conducted in the North pool. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.
- Timing:** Colorado System with button and watch back-up. Computerized scoreboard for all lanes.
- Official Rules:** Official current USA Swimming and Wisconsin LSC rules shall prevail for this meet. Swimmers must be registered USA swimmers with their age as of February 10, 2018. Coaches must be USA registered.
- Disabled Swimmers:** Please note any special requirements for disabled swimmers on the entry form.

- Entry Deadlines:** A meet event file will be available at our team web site: www.lakecountryswimming.com. Submit entries via e-mail using Hy-Tek. Email entry must be received no later than **Wednesday, January 31st, 2018**. Waiver, fees and hard copy of entry listed by swimmer name must arrive by Friday, February 5th. Deck entries will be allowed at the discretion of the meet director to fill open lanes.
- Entry Limit:** **Swimmers may enter a maximum of eight (8) individual events for the meet. Swimmers are limited to five (5) individual events per day.** Enter in short course yards.
- Racing Start Certification:** Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Fees:** Individual events are \$5.00 per event. All swimmers entered in at least one individual event must pay the \$3.00 Wisconsin Swimming LSC surcharge and the \$4.00 WSAC Facility surcharge. Make checks payable to **Lake Country Swim Team**. Entry fees must accompany the official entry form and are not refundable. Deck entries will be \$10.00/event for individual entry.
- Meet Format:** All events will be timed finals. Positive check-in is required for the Open 400 IM and 500 freestyle events. All other events will be pre-seeded.
- Admissions:** \$6.00 per day admission, \$3.00 heat sheet for each session. Spectators will be asked to show proof of admission upon entering pool area.
- Final Results:** Final results will be emailed to participating teams and posted on the Wisconsin LSC and Lake Country Swim Team's website.
- Conduct:** Each team is responsible for the conduct of its swimmers and parents. All on deck seating will be reserved for use by the athletes and coaches. No videotaping or picture taking allowed in any area of the stair wells or upper stair well landing areas. Cell phones and other recording devices are not allowed in the locker room. Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker room or other designated areas is prohibited. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair
- Awards:** Ribbons 1st through 8th place for 8-Under, 10-Under and 11-12.
Special State Qualifier Awards for new state cuts.
Please note: No awards will be mailed following the meet.
- Food:** According to the Brown Deer Health department, there will be no food or beverages allowed to be brought into the Schroeder Aquatic Center by spectators. This includes the cafeteria area. Athletes are allowed to bring refreshments (liquids) but **NO GLASS** is allowed. There will be a superb selection of food and beverages available at all times during the meet.
