**Facility:** 8-lane, 25-yard pool with a starting depth of 4½-5 feet and a turn depth of 4 feet. It has

regulation-height starting blocks (30") and ample viewing area for athletes and spectators. 8&U relay swimmers opposite the starting blocks will start in the water. The Competition Course has

not been certified in accordance with USA Swimming's Rule 104.2.2C(4)

**Timing System:** Daktronics Timing System with horn start, touch pads, one button, and 2 watches as backup. All

25-yard races will be started at the starting end with using two stopwatches.

**Eligibility:** All swimmers must be currently registered with USA Swimming. Swimmer's age as of November

13, 2016 shall determine their age group for the meet. Out of state entrants must present a valid

2016-17 USA S card at the Scoring/Records Table prior to pool entry.

**Rules:** Official 2016 USA Swimming and WI LSC rules shall prevail at this meet.

**Format:** All events will be pre-seeded. 8 & Under events will be staged. Heats may be combined to stay

within 4 hour rule. All events are timed finals.

**Entry Limit:** Participation is limited to a maximum of four (4) events per day, plus relays. Age is to be

determined as of November 12, 2017.

**Entry Fees:** \$5.00 per individual event.

\$12.00 per relay.

\$3.00 WI LSC Splash fee per individual swimmer entered in the meet.

**Deck Entries:** The entry fee for deck entries will be \$10.00 per individual event and \$15.00 for relays. Deck

entries will be allowed at the discretion of the Meet Director and only to fill open lanes if the time line permits. Additional heats will not be added. Deck entries close 30 minutes prior to the start

of the session.

Disabled Swimmers: Coaches are encouraged to inform Officials and Meet Director of any special needs swimmers

prior to the start of warm-ups.

**Relays:** Relay cards will be in the coaches' packet. Cards must list the swimmers' last and first names

(names must be listed in order of swim) and the ages of the swimmers.

Coaches:

Any monies owed must be paid before you can obtain your packet. Please be prepared to show your USA Swimming Coach's Card at the time of picking up your packet. Coach's cards must be visible at all times on deck.

Warm-ups:

Sunday AM Session: Warm-ups 7:00-8:00 AM. Meet start 8:05 AM

Wisconsin Swimming warm-up procedures will be in effect. Morning session will have 30 minutes of circle swimming with no racing starts. Feet first three-point entry from the starting end during general warm-ups will be enforced unless performing one way starts. During the second 30 minutes, sprint lanes will be opened as needed. The afternoon session will use the same format. Violators of the WI Swimming warm-up procedures may be subject to disqualification.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer of the swimmer's legal quardian to ensure compliance with this requirement.

Awards:

Individual Events - Ribbons 1<sup>st</sup> – 16<sup>th</sup> for 12 & Under individual events.

Relay Events - 1<sup>st</sup> - 3<sup>rd</sup> for 12 & Under

Awards must be picked up at the meet. No awards will be mailed.

**Admission:** 

\$5.00 per day for spectators over 12 years old. Heat sheets will be available to print from our website, on Meet Mobile, and sent to each team's entry chair for distribution.

Concessions:

Food and beverages will be available on the premises. No food nor beverages are allowed in the

pool area.

**Conduct:** 

Each team is responsible for the conduct of its swimmers. In compliance with the Video Prevention Act the use of any recording device is prohibited in the locker room.

Except where the venue facility requires otherwise, changing in or out of swimsuits other than in locker rooms and other designated areas is not appropriate and prohibited.

Meet Marshals shall have the authority to remove any swimmer/s from the meet for any violation such as improper behavior, damage to property, etc. Such teams are responsible financially for damage of property. Please make sure your team's area on deck and rest area is picked up at the end of each session.

Limited seating for spectators with disabilities can be provided. Notify the Meet Director if assistance is needed.

First Aid:

Injuries must be reported to the Lifeguard and to the Meet Director. A first aid kit will be located at the Lifeguard station.

Lost & Found:

Items not picked up by meet end will be kept with Meet Director for one week following meet and then donated.
