You cannot send your meet for sanctioning until the “OFFICIAL” meet schedule has been voted on and approved on Tuesday, June 28th, 2011 - I will have the Official 2012 Winter Meet Schedule posted on Wisconsin Swimming’s website by Friday, July 1st, 2011.

Please refer to Policy 2.2.1 – Meet Entry Information for the listing of what should be included in your meet information. Also remember that Policy 2.2.1(R) requires that the Name of the Meet Referee be listed on the meet information. Any meets turned in for sanctioning/approval will be returned to the meet director and not sanctioned until the name of the meet referee is included in the meet information.

APPROVED MEETS: Any team requesting to host an “approved” meet must also complete Form F and this form must accompany your meet bid. The Sanctioning Chair will then forward the request (along with a copy of the meet information) to USA Swimming for their approval.

REMINDER: The 2012 Winter Championship hosted meets have already been voted on at the March 2011 House of Delegates meeting and will appear on the UNOFFICIAL Schedule.
