## Hosted by Ashwaubenon Swim Club and Howard Suamico Storm Breakers

- Date:** July 21-23, 2006
- Location:** Clintonville Rec Center, Clintonville High School, 330 North Harriet Street, Clintonville, WI 54929
- Facility:** Eight (8) lane, 25 yard, 7' lane width, backstroke flags, non-turbulence lane dividers  
Starting depth – 6'8" on edge lanes, sloping down to 10' in center lanes; turn side depth –3'6"  
Block height – 25"  
Colorado Timing System with Backup Stop Watches (2 per lane)
- Classification:** Silver Meet Time Standards, Wisconsin LSC dictated.
- Rules & Eligibility:** 2006 USA and Wisconsin LSC rules shall prevail for this meet. Swimmers must be registered with USA Swimming.
- Qualification Procedure:** Swimmers must have achieved the minimum time standard for all the events entered and **CANNOT** swim an event if the State qualifying time standard has been met prior to the entry deadline. Please see Silver Meet time standards posted on the Wisconsin Swimming website at [www.wisconsinswimming.org](http://www.wisconsinswimming.org). Swimmers are only allowed to swim in their respective age group; only swimmers ages 13 and up can swim in Senior events.
- If swimmers age-up after the Silver Meet and do not currently have State Qualifying Times for the next age-group they will enter, swimmers will be allowed to swim the event in their current age-group at the Silver Meet (regardless if they exceed the Silver Meet time standards). Please indicate this on the hardcopy you submit to the host clubs.**

- Warm-ups:** General warm-ups/circle swimming in all lanes for each warm-up session. Push-pace and sprint lines will be opened and closed as necessary by the Meet Director and Meet Marshals.
- Entry Limit:** 7 events total for the meet (no more than 5 on any day, including time trials).
- Relays:** Relays will not be contested.
- Entry Deadline:** Tuesday, July 11, 2006.
- Entry Fees:** \$4.00 per event  
\$3.00 WI LSC splash fee per swimmer.
- Hy-Tek File:** A Hy-tek events file for downloading into Team Manager will be available on the Northern Silver Meet website ([www.geocities.com/silver\\_entries](http://www.geocities.com/silver_entries)).

- Deck Seeding: Deck entries will be accepted in open lanes only. Swimmers must already be entered in the meet and be able to provide printed meet results proving the time standard was met after the entry deadline.
- Deck Registrations: Deck registrations will not be accepted.
- Non-Conforming Times: **DO NOT CONVERT.** Swimmers must be entered at their best time. All courses will be used. Non-conforming times will be seeded after SCY times. The order used for seeding will be SCY-SCM-LCM.
- Timing System: Colorado with scoreboard and touch pads. Two backup timers per lane.
- Adaptive Swimmers: Please indicate on the entries form any special needs for those athletes requiring assistance. If a swimmer thinks s/he may qualify as an adaptive swimmer please contact the Age-Group or Senior Chair for time standards. Also, please inform the Head Official of those needs prior to the start of the meet.
- Awards: Ribbons: 1<sup>st</sup> – 16<sup>th</sup> place  
**Any awards not picked up during the course of the meet will be bagged and either handed out at the 12 & Under Wisconsin LCM State Championships (July 28-30, 2006), the 13 & Over Wisconsin LCM State Championships (August 4-6, 2006), or mailed.**
- Coaches: Meet packets can be picked up at the Meet Management table on the pool deck. All outstanding entry fees must be paid when picking up the meet packet. There will be a brief coaches meeting before the start of each day's meet. Meeting location and time will be announced during warm-ups.
- Scoring: This meet is not scored.
- Officials: To be announced at a later date.
- Meet Conduct: Each club is responsible for the conduct of its swimmers. Any person who, in the opinion of the Meet Director or Meet Marshal, is harmful to others or to other's property will be required to leave the competition. Please sit in the designated areas for teams and spectators. All spectator seating is in the bleachers on the east side of the pool deck. All swimmers must keep their swim bags in the team seating areas. In accordance with USA Swimming rules, **NO SPECTATORS ARE ALLOWED ON THE POOL DECK.**
- Admissions and Heat Sheets: There will be a charge for admission of \$2.00 per day. (Under 12 and Seniors – No Charge)  
Heat sheets will be available for \$3.00 per day.
- Parking: See attached map. Please park only in designated lots – **only** recreation center members are allowed to park in the small lot in front of the rec center.
- Final Results: A meet back-up will be posted at [www.wisconsinswimming.org](http://www.wisconsinswimming.org).
- Apparel: All-American Aquatics will be on-site with goggles, suits, etc. A limited number of Silver Meet event t-shirts will also be available.
- Concessions: Delicious hot and cold foods will be available for purchase during the meet and must be eaten in the cafeteria or multi-purpose gym.. **NO GLASS CONTAINERS ALLOWED ON THE POOL DECK.**
- Lost & Found: Swimmers are responsible for their own belongings. Lost & Found articles will be located at the awards table during the meet. After the meet call (920) 490-2003.

## Time Trials

### WI Sanction #2006-084WI

*Time Trials are available only to those swimmers entered in the Silver Meet.*

- Times:** Time Trials will be offered Saturday and Sunday and/or as time permits and at the discretion of the Meet Director as per LSC mandate.
- Events:** See meet order of events listing.
- Fees:** \$5.00 for individual events.
- Registration:** At the Meet Management table located on the pool deck. Entries will be accepted during all sessions up to 30 minutes prior to the end of the Senior session (swimmers in the last event of the day have 10 minutes after the end of that event to sign-up for Time Trials).
- Procedure:** Swimmer will sign-up for an event at the Meet Management table. Swimmer will fill out a seed card at the table – swimmer's name, age, team, event name, and seedtime. Seed card and event fee must be turned into the Meet Management table before the registration deadline. A meeting for all Time Trial participants and timers will be held prior to the start of Time Trials. Cards with heat and lane assignments will be handed out during the meeting. It is the swimmer's responsibility to be ready to swim when her/his event, name, and lane number is called. The Referee will not hold the start of the event, waiting for a swimmer (or timer) to show. An announcement will be made that Time Trials are beginning and swimmers and timers should report to the meeting immediately. ALL Time Trial cards (whether or not a swimmer swim a desired time) MUST be turned in at the end of each heat.
- Meet Host Provides:** Officials, Timing System Operator, and Meet Management.
- Swimmer Provides:** Two (2) timers, two (2) watches, and counter (if needed).
- Reminders:** The maximum number of individual events in one day is five (5) and includes Time Trials (USA 102.2.5 and 102.2.6). This means that a swimmer may swim 5 individual events total per day, including a combination of:
- 1) only Time Trials
  - 2) combined Time Trials and meet events or
  - 3) only meet events

Time Trials will begin promptly. It is the responsibility of the swimmer to be at the blocks, complete with her/his two timers (and two watches), ready to swim.

Timers must turn in their cards whether or not a swimmer achieves a desired cut time.

High School will be on the right. Enter at the 4-way stop sign (Harriet Street) and park in the back parking lot.

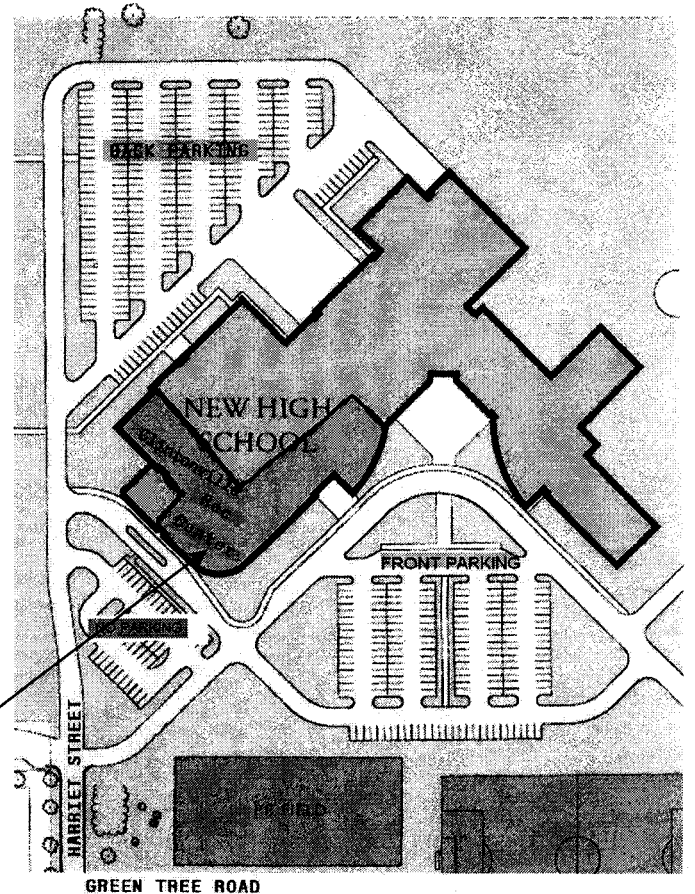
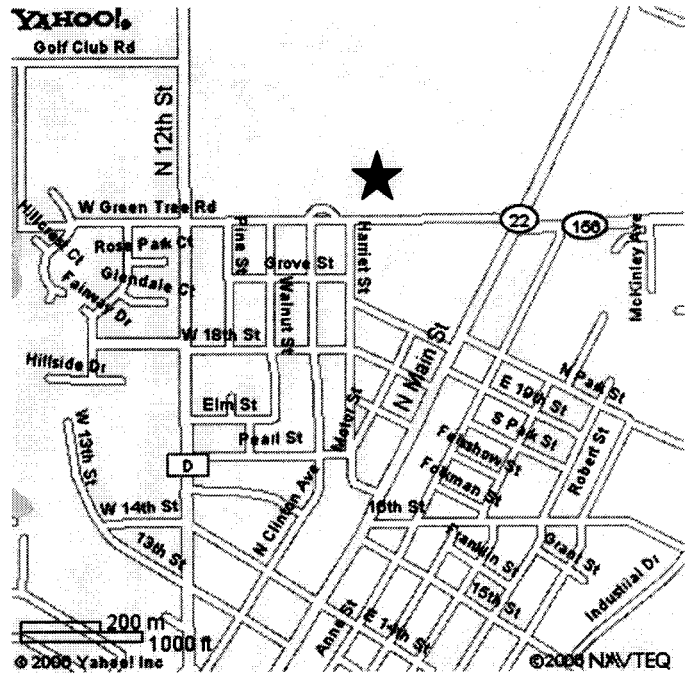
