FAST Masters is a year-round program. Fees are paid monthly, by trimester, or annually. Monthly payments are due on the tenth (10th) day of each month. Trimester payments are due on September 10th, January 10th, and April 10th. There are no refunds. A late fee of \$25.00 is assessed if payment is received after the 20th day of the month in which payment is due. Returned checks will incur a service fee of \$50.00. Swimmers who are in default of payment will not be permitted to attend practice until their account is reconciled. All swimmers must be current members of United States Masters Swimming (USMS).
