## 2012-2013 Tuition & Fees

Families may make a one-time payment for the Annual Training Fee or three Trimester Payments throughout the year on September 10<sup>th</sup>, January 10<sup>th</sup>, and April 10<sup>th</sup>. **Trimester payments received after the tenth day of the month in which they are due will incur a \$25.00 late fee.** Swimmers whose accounts are delinquent by 30 days will not be permitted to participate in practice sessions until their account is reconciled. Additionally, FAST requires families to authorize a credit card on their account to simplify the billing process. Families with more than one swimmer enrolled receive a \$50.00 per trimester discount for every second or additional swimmer. Families that opt to make a one-time payment in September will receive a 10% discount applied to their Annual Training Fee or an Arena technical racing suit (only available in size 24 or higher).

**In addition to training fees, each family will maintain a Meet Escrow Account which covers the cost of meet entries.** If and when the balance of your escrow account falls below \$25.00, FAST will automatically replenish the balance using the credit card on file. Swimmers will be expected to compete in all meets on their group's schedule and will therefore be automatically entered. Families may "opt out" of a particular meet if they do so by the opt out date, but meet fees will not be refunded once a swimmer has been entered. Any escrow balance that remains on August 31, 2013 rolls over to the next year. If a swimmer does not return to the team, the escrow balance will be refunded. Collegiate swimmers may maintain a meet escrow account, but it is not required.

### Enrollment Agreement

My signature below indicates agreement with the following, and acknowledgment that non-compliance with any of the following is reason for suspension or expulsion from FAST:

- All swimmers who register with FAST must become members of USA Swimming, Inc. (USAS) and/or U.S. Masters Swimming (USMS). All registered swimmers incur an Annual Training Fee and a Meet Escrow Fee. Parents, guardians, and sponsors of FAST swimmers are responsible for the financial obligations of each swimmer and are required to volunteer time at FAST swim meets and special events.
- Fees are based upon the most advanced swimmer in the family. **There will be NO REFUNDS.** Swimmers in default of payment will not be permitted to attend practice until their account is reconciled. Tuition must be paid in full or in three installments throughout the year on September 10<sup>th</sup>, January 10<sup>th</sup>, and April 10<sup>th</sup>. A late fee of \$25.00 will be assessed if a payment is received after the 10<sup>th</sup> day of the month in which it is due. Returned checks will incur a service fee of \$50.00.
- Team structure and fees are based upon a year-long commitment to competitive swimming. To resign from FAST, families must mail or deliver a signed and dated form to the FAST Head Coach notifying cancellation of this agreement. This form can be found on the FAST website. All tuition and fees must be paid in full upon termination. Delinquent accounts will be reported to Southern California Swimming.
