Florida Swimming mandates that all persons follow COVID guidelines as required by facility and local protocols including but not limited to mask and social distancing policies.

Please follow host meet letter guidelines.

Florida Swimming will not be responsible for enforcing facility protocols however participation in the meet must adhere to facility guidelines.

Sanctioned by: Florida Swimming of USA Swimming # **FL-5709**
"In granting this approval it is understood and agreed the USA Swimming/Florida Swimming shall be free and held harmless from any liabilities or claims for damages arising by reason of injuries to anyone during conduct of the event".

Condition of Sanction:

- Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.
- Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and prohibited.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the USA-S Vice President of Operations
- All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- COVID Prevention: In applying for this sanction, the host, Episcopal AmberJax, agrees to enforce all health and safety mandates and guidelines by USA Swimming, Florida Swimming, the State of Florida, and the Episcopal School of Jacksonville. Please Note: An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and individuals with underlying medical conditions are especially vulnerable. USA Swimming, Inc., cannot prevent you (or your child(ren)) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming sanctioned events. It is not possible to prevent against the presence of the disease. Therefore, if you choose to participate in a USA Swimming sanctioned event, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19. - Type of Meet: 25-yard Course, Timed Finals
No qualifying times will be required. Meet management may use fly-over starts at this competition.
- Dates & Times: Saturday, September 18th - Timed Finals 8:30 AM, 11 & Up (Session 1)
Saturday, September 18th - Timed Finals Begins 45 minutes after completion of session one, 10 & Under (Session 2)
Sunday, September 19th- Timed Finals 8:30AM, 11 & U (Session 3)
Sunday September 19th - Timed Finals begins 45 minutes after completion of session three, 10 & Under. (Session 4)
- Location: Episcopal School of Jacksonville

- Pool Specifications: Two outdoor 25 yard, 6, 8, 10 lane courses with non-turbulent lane lines.
Water depth at all parts of the pool is a minimum of 5 feet.
Regulation KDI Paragon Starting Blocks.
If two courses are used for competition, there will be one buffer lane and at least 3 lanes for continuous warm up/warm down.
- Timing Equipment: Colorado timing system, touch pads and stopwatches will be used.
Hy-Tek Meet Manager will be used to score the meet.
- Eligibility: Open to all currently registered USA Swimming swimmers who are members of invited teams. On deck registration will be allowed. 2022 USA-S form and fee must be presented to the Referee.
- Entry Limit: The total number of entries will be limited as not to exceed the 4-hour rule. The team whose entries put the meet over 500 will be the final team allowed in the meet. Swimmers are limited to four (4) individual

events per session plus relays. Swimmers over entered will be considered as entered in the first four events.

- Seeding: Use of 25-yard course times to be used for seeding. Conversions, using the formula in the current Florida Swimming handbook may be used for entry and seeding purposes.
- Scratch Penalty: No penalty for scratching on the block with the exception of deck seeded events. Any swimmer entered in a deck seeded event that has checked in for the event must swim the event unless he/she notifies the Meet Referee before the seeding has begun that he/she wishes to scratch. Failure to do so will result in the swimmer being barred from his/her next individual event in which he/she is entered on that day or the next day of the meet, whichever is first.
- Entries: Entries must be in USA Swimming SDIF format or Hy-Tek CL2 format. A signed hard copy printout is acceptable as proof of entry in place of the enclosed entry forms. Free test emails will not be accepted. Disk and e-mail entries will not be accepted that are not accompanied by a hard copy entry, including the Master Entry Form. List all attending coaches, contact phone numbers, and RELAY ONLY swimmers in the body of the e-mail. Include the total number of swimmers and events in the body of the email. Corrupted, unreadable, or incorrectly formatted files must be corrected within 24 hours. Errors in entries submitted electronically are the responsibility of the applicant. Electronic mail confirmation will be sent upon receipt of file. If using the enclosed Entry form, the form will serve as proof of entry. The legal name and current USA swimming registration number for each swimmer must be listed on the Entry form, including "relay -only" swimmers. The master entry form must accompany the proof of entries and a current USA swimming Member must sign the form. Florida Swimming rules require a \$50 penalty from teams that do not submit their entries in Hy-Tek format.
- Deck Entries: Deck entries may be accepted by the meet referee or his/her designee at his/her discretion:
*Swimmers must meet all other eligibility and entry limit standard requirements of the meet.
*Entry & meet fees must be paid at time of entry
*A swimmer may not scratch an event to deck enter an event.
- Entry Fee: Timed Finals \$4.15 per individual event
Relay \$5.00 per relay team
Facility Fee \$10.00 per swimmer
Heat Sheet Surcharge \$2.00 per swimmer

Team Representative: Prior to the start of the meet, the name of one person other than the coach, who will check with the referee about any matter pertaining to the meet, may be given to the referee. For each team, the coach and that person only will be recognized.

Identification: All coaches and officials shall wear their USA Swimming registration card in a conspicuous location at all times while on deck or show current USA-S coach membership on Deck Pass during a swim meet.

Rules: Current USA Swimming Rules and Regulations will govern.
Safety Rules, as outlined by USA Swimming, will be in effect during all warmups and sessions.
Fly Over starts may be used at this competition
Meet Referee may, at its discretion, combine heats.

- Officials Briefing: Officials Briefing will be held one hour prior to the start of each session. Visiting officials are welcomes and appreciated.
- Meet Committee: A meet committee to be composed of the meet referee, home team coach and three other coaches chosen at the first coaches meeting will meet as needed to make decisions regarding the meet, in the event of inclement weather or at other time as requested by the Meet Referee.
- Supervision: A current USA swimming member Coach must supervise each swimmer participating in a Florida Swimming sanctioned meet during warm up and competition. An unattached athlete or an athlete not escorted by a member coach must check in with the Admin Referee upon arrival at the meet. Such athlete must find a substitute coach who will supervise him/her during warm-up and competition and must submit the enclosed alternate contact form (signed) to the Admin Official.
- Heat Sheets: Will be available online there is a \$2.00 Surcharge per swimmer
- Camera Zone: Per Florida Swimming Rule 223.13, Meet management shall designate and inform the public of "Camera Zones" at each swim meet where both still photography and video photography of a race of a competitor in a race may be taken. Acceptable "Camera Zones" may include, but are not limited to the side courses of a pool, team gathering areas, concession area, turn end of competition course when not in use as a "start end". Meet management shall also designate "Non-Camera Zones." Under NO circumstances will Camera Zones include the area immediately behind the starting blocks at either end of the racing course (s) while they are in use for "racing start purposes" during competition and warm-ups, locker rooms, rest rooms, or any other dressing area. Any individual failing to abide by this rule could be subject to Florida Code of Conduct violation as defined in Rule 239.2.
