Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer’s legal guardian to ensure compliance with this requirement.

The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming OR the competition course has not been certified in accordance with 104.2.2(C).

Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited and is strongly discouraged.

Operation of a drone, or any other flying apparatus, is prohibited over the venue) pools, athlete/coach areas. Spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the USA-S Vice President of program operations.

All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy (“MAAPP”), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.

Pool Specs: 1 x 8 or 10 lane 25-yard competition course. Water depth is 5 – 8 feet start and turnend.

Timing Equipment: Daktronics Omnisport 2000 Timing system with scoreboard, Hy-tek computer seeding and scoring will be used. Button and handheld back-ups will be used.

Seeding: 25-yard times will be used for seeding.

Scratches: No penalty for scratching on the block.

Heat Sheets: Heat sheets will be posted on silverhawkaquatics.com and e-mailed to all competing teams' contact person no later than 48 hours prior to the start of the meet. These are to be printed and brought to the meet. A \$2.00 charge will be applied to each swimmer's entry fee. NO HEAT SHEETS WILL BE AVAILABLE FOR PURCHASE AT THE MEET! Coaches will also be required to print out their own heat sheet for this meet. THERE WILL BE NO HEAT SHEETS AT THE MEET FOR COACHES! Coaches, please make your teams aware of this.

Eligibility: USA Swimming registered athletes. Entries will close with the team that puts us over the 4 hour rule. Meet management may elect to run two 8-lane courses or one 10-lane course. Meet management may elect to combine sessions based on the number of entries received. Teams will be notified of any changes to sessions by e-mail no later than Wednesday, December 1st. By Invitation Only – Blue Dolphins, Patriot Aquatics, Southwest Star Aquatics and Silverhawk Aquatics.

Entry Limit: Swimmers are limited to (4) individual events per session.

Entry Form: Entries must be in USA Swimming Hy-Tek CL2 format and submitted on a Hy-Tek disk, or sent by email using Hy-Tek team manager. Corrupted, unreadable, or incorrectly formatted files must be corrected within 24 hours. Errors in entries submitted electronically are the responsibility of the applicant. Deck Entries: Deck entries are to be submitted to meet management no later than 30 minutes prior to the start of each session. The fee for deck entries is \$10.00 per event and must be paid at the time the entry is made. Deck entry will be accepted only if there are open lanes in the desired event. NO NEW HEATS WILL BE CREATED. Swimmers must still comply with the maximum per session entry limits and other eligibility requirements. Swimmers may not scratch an event in order to deck enter a new event. Proof of USA Swimming registration must be met.

- Coaches/Officials: Coaches and officials shall wear their USA Swimming registration card in a conspicuous location at all times while on deck during a swim meet or provide current registration with Deck Pass.
- Coach Supervision: Each swimmer participating in a Florida Swimming sanctioned meet must be supervised during warm-up and competition by a current coach member of USA Swimming. An unattached athlete or an athlete not escorted by a coach member must check in with the meet referee upon arrival at the meet. Such athletes must find a substitute coach who will supervise him/her during warm up and competition and must submit the enclosed alternate coaches form (signed) to the meet referee.
- Camera Zones: Per Florida Swimming Rule 223.13, Meet Management shall designate and inform the public of "Camera Zones" at each swim meet where both still photography and video photography of a race or a competitor in a race may be taken. Acceptable "Camera Zones" may include, but are not limited to the side courses of a pool, team gathering areas, concession area, turn-end of competition course when not in use as a "start end," etc. Meet Management shall also designate "Non-Camera Zones." Under NO circumstances will Camera Zones include the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for "race starting purposes" during competition and warm-ups, locker rooms, restrooms, or any other dressing area. Any individual failing to abide by this rule could be subject to the Florida Swimming Code of Conduct violation as defined in Rule 239.2.
