Sanctioned by: Florida Swimming of USA Swimming
_____ "In granting this approval it is understood and agreed that USA Swimming and Florida Swimming shall be free and held harmless from any liabilities or claims from damages arising by reason of injuries to anyone during the conduct of the event."

Condition of Sanction:

- Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming. OR The competition course has not been certified in accordance with 104.2.2(C).
- Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and prohibited.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the USA-S Vice President of Operations
- All applicable adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
- COVID Prevention: In applying for this sanction, the host, Episcopal AmberJax, agrees to enforce all health and safety mandates and guidelines by USA Swimming, Florida Swimming, the State of Florida, and the Episcopal School of Jacksonville.
- Please Note: An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and individuals with underlying medical conditions are especially vulnerable. USA Swimming, Inc., cannot prevent you (or your child(ren)) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming sanctioned events. BY ATTENDING OR PARTICIPATING IN THIS COMPETITION, YOU VOLUNTARILY ASSUME ALL RISKS ASSOCIATED WITH EXPOSURE TO COVID-19 AND FOREVER RELEASE AND HOLD HARMLESS USA SWIMMING AND FLORIDA SWIMMING AND EACH OF THEIR OFFICERS, DIRECTORS, AGENTS, EMPLOYEES OR OTHER REPRESENTATIVES FROM ANY LIABILITY OR CLAIMS INCLUDING FOR PERSONAL INJURIES, DEATH, DISEASE OR PROPERTY LOSSES, OR ANY OTHER LOSS, INCLUDING BUT NOT LIMITED TO CLAIMS OF NEGLIGENCE AND GIVE UP ANY CLAIMS YOU MAY HAVE TO SEEK DAMAGES, WHETHER KNOWN OR UNKNOWN, FORESEEN OR UNFORESEEN, IN CONNECTION WITH EXPOSURE, INFECTION, AND/OR SPREAD OF COVID-19 RELATED TO PARTICIPATION IN THIS COMPETITION.

- a. The pool deck and Jangro Stadium will be closed to spectators. Only coaches, officials, volunteers and swimmers in that particular practice/meet are allowed on deck. Spectators may view from the perimeter of the pool should they desire while maintaining all social guidelines posted. Parents may set up and sit with their families in specified team sections on the track.
- b. Locker Rooms will be closed for changing in and out of swimwear.
- c. Swimmers, Officials and Coaches will have their temperature checked at the ticket gate before as they are entering for competition.
- d. We will be adhering to all "Covid Protections and Practices and Modifications" guidelines set forth by the facility, which can be found at <https://www.esj.org/operationalplan/> *These guidelines are a living document and subject to change*

Type of Meet:

50 Meter Course Prelim/Finals. One (8) Lane Course. No qualifying times will be required. Meet management may use fly-over starts at this competition.

Pool Specs: One outdoor 50 Meter 10 Lane pool with non-turbulent lane lines. Water depth at all parts is a minimum of 5 feet. Regulation KDI Paragon Starting Blocks. There will be at least one lane for continuous warm up/cool down.

Timing: Colorado Timing System, touch pads will be used. Hy-Tek Meet Manager will be used to score the meet.

Eligibility: Open to all currently registered USA Swimming swimmers who are members of invited teams. On deck registration will be not allowed.

Entry Limit: The total number of entries will be limited as to not exceed the 4-hour rule. The team whose entries put the meet over 500 Swimmers will be the final team allowed in the meet. **13 and Over Swimmers are limited to three (3) individual events per session. 12 & Under Swimmers will be limited to (4) individual events per session. Swimmers over entered will be considered in the first three events (13&Up) or first four events (12 & U).**

Seeding: Use 50-Meter Long Course times. Conversions, using the formula in the current Florida Swimming Handbook may be used, for entry and seeding purposes.

Scratch Penalty:

Prelims: No penalty for scratching on the block in prelims with the exception of deck seeded events. Any swimmer entered in a deck seeded event that has checked in for the event must swim the event unless he/she notifies the clerk of course before the seeding has begun that he/she wishes to scratch. Failure to do so will result in the swimmer being barred from his/her next individual event in which he/she is entered on that day or the next day of the meet, whichever is first.

Finals: Any swimmer who competes in a preliminary heat and qualifies as one of the finalists, as originally seeded, must swim in that event final; or must notify the clerk of course that he/she intends to scratch from that final's event, within 30 minutes of the announcement of the qualifiers. Swimmers may reverse their intention to scratch and choose to be seeded for finals if they do so within 30 minutes of their last prelim event of the day. Any swimmer seeded in a final who fails to swim that event will be barred from their next event unless excused by the meet referee because of illness or injury. A swimmer not originally qualified for finals who is seeded into a final due to the scratch of another swimmer will not be penalized for failing to swim in that final.

Entries: Entries must be submitted on the enclosed entry form, which will serve as proof of entry. All current USA Swimming registration numbers, including relay only swimmers, must be listed on the entry form, and the form must be signed by a current USA Swimming Member. The Master Entry Form must accompany the proof of entries. *Hy-Tek Disk with a signed hard copy printout is acceptable as proof of entry in place of the enclosed entry forms. A Master Entry Form must be included. NOTE: Check with the computer operator for any details that would be required if submitting by disk that would be helpful to include in this information. *Entries must be in USA Swimming SDIF format or Hy-Tek CL2 format. A signed hard copy printout is acceptable as proof of entry in place of the enclosed entry forms. Free text e-mail entries will not be accepted. Disk or e-mailed entries must be accompanied by a backup hard copy of the entry. List all attending coaches, contact phone numbers, and RELAY ONLY swimmers in the body of the e-mail. Corrupted, unreadable, or incorrectly formatted files must be corrected within 24 hours. Errors in entries submitted electronically are the responsibility of the applicant. Electronic mail confirmation will be sent upon receipt of file. If using the enclosed Entry Form, the form will serve as proof of entry. The legal name and current USA Swimming Registration Number for each swimmer must be listed on the Entry Form, including "relay-only" swimmers. The Master Entry Form must accompany the proof of entries and a current USA Swimming Member must sign the form.

Team Rep: Prior to the start of the meet, the name of one person other than the coach, who will check with the referee about any matter pertaining to the meet, may be given to the referee. For each team, the coach and that person only will be recognized. Identification: Coaches and Officials shall wear their USA Swimming

Identification:

Coaches and Officials shall wear their USA Swimming registration card in a conspicuous location at all times while on deck during the meet or prove current registration through Deck Pass. Coaches must show proof of membership before swimmers compete in any event to the Meet Referee.

Rules:

Current USA Swimming Rules and Regulations will govern.

Safety Rules, as outlined by USA Swimming, will be in effect during all warm ups and sessions.

Fly-over starts may be used.

Officials Briefing will be held one hour prior to each session. Visiting officials are welcomed and appreciated. Please contact: zuberom@esj.org

Meet Committee:

A meet committee will be composed by the meet referee, home team coach and three other coaches chosen at the first coaches meeting will meet as necessary to make decisions regarding weather or at other times as requested by the meet referee.

Supervision:

A current USA Swimming member coach must supervise each swimmer participating in a Florida Swimming sanctioned meet during warm up and competition. An unattached swimmer or an athlete not escorted by a coach must check in with the Admin Referee upon the arrival at the meet. Such athletes must find a substitute coach who will supervise him/her during the meet warm-up and competition. Athlete must submit alternate contact form to Admin Official.

Camera Zone:

Per Florida Swimming Rule 223.13, Meet Management shall designate and Inform the public of "Camera Zones" at each swim meet where both still photography and video photography of a race or a competitor in a race may be taken. Acceptable "Camera Zones" may include, but are not limited to the side courses of a pool, team gathering areas, concession area, turn-end of competition course when not in use as a "start-end," etc. Meet Management shall also designate "Non-Camera Zones." Under NO circumstances will Camera Zones include the area immediately behind the starting blocks at either end of the racing course(s) while they are in use for "race starting purposes" during competition and warm-ups, locker rooms, restrooms, or any other dressing area. Any individual failing to abide by this rule could be subject to the Florida Swimming Code of Conduct violation as defined in Rule 239.2.
