STANDARD OPERATING PROCEDURES

- PPE requirements:
 - o All coaches will wear masks when checking in athletes and facilitating athlete exit. Coaches may remove masks once all athletes have entered the water.
 - o Coaches or board member should wear gloves when cleaning all touchpoints within a facility.
 - o All athletes will wear masks entering and exiting the facility, on deck and during dryland activities. If space permits over 6 feet of separation between athletes, masks are not required during dryland workouts. Exceptions will be made for athletes with conditions that prohibit them from wearing a mask pending medical documentation.
- Social distancing requirements:
 - o Athletes and coaches must maintain 6 feet distance at all times. There will be spaces indicated along the entrance for athletes to line up 6 feet apart. There will be designated baskets or spaces on the pool deck for athletes to leave their personal belongings to ensure social distancing.
- Once athletes enter the facility, they will go to their indicated lane and await instructions from their coach.
- Facility procedures:
 - o There will be a one-way entrance and one-way exit.
 - o Locker rooms will not be available and restrooms for emergency use only.

- o The facility will be cleaned daily following all practices.
- o Athletes should take temperature at home right before coming to practice and remember the temperature reading to relay to their coach. Athletes with a temperature of 100.4 degrees will not be permitted at practice.
- Temperatures will not be recorded.
- Athlete/family protocol:
 - o Athletes must arrive and depart in their swimsuit. Athletes will not be able to change at the facility. Maui County requires showering before entering the pool. No shower prior to leaving the facility.
 - o Athletes will only be permitted to line up to enter 5 to 10 minutes before their scheduled practice time. If they arrive early, they should wait in/by their car until the appropriate time to enter the facility. Athletes must leave the facility immediately at the completion of any practice.
 - o Parents/spectators will not be allowed in the facility at any time and are expected to practice social distancing while waiting for their athlete. We will ensure that the appropriate number of coaches are present during each practice to comply with MAAPP.
 - o Athletes should bring their own water bottle (already filled) and any other equipment required by their coach. Coach will not be allowed to 'fix' any equipment malfunctions.
 - o Criteria that must be met by athlete and anyone residing in their household in order to be eligible to attend practice:
Cannot have had contact with anyone who has tested positive for COVID-19 in the last 14 days. Cannot have had

a temperature over 100.4 degrees, a cough or difficulty breathing in the last 14 days.

- If the athlete or anyone residing in their household has traveled over 100 miles or by air, the coach must be notified over email.
- International travel requires an automatic 14-day return period with no symptoms before returning to practice.
 - o Any athlete or staff member experiencing any symptoms of a fever, recent cough, unusual fatigue, headache or has had any exposure to someone who has any symptoms should remain at home and seek medical treatment. If any athlete or staff member has a fever or symptoms of illnesses, they may not attend practice until 14 days after the fever or symptoms has ceased. Athletes and staff must see a physician and be cleared for training after being diagnosed or suspected to have COVID-19.
 - o For us all to stay healthy and be able to keep swimming, we ask our athletes to please practice responsible social distancing when they are away from the pool as well.
 - o Should we feel anyone is consistently not adhering to social distancing guidelines, they or their family's participation in MDSC activities may be suspended.
- Positive test procedure:
 - o Should someone test positive for COVID-19 within the membership, the following measures will take place: The individual should let the staff know immediately. The board of directors will inform the lifeguard staff and member families.
