



# RAINBOW AQUATICS SWIM TEAM

## TERMS AND CONDITIONS OF PARTICIPATION

### **Forms & Fees**

For insurance purposes, the following must be submitted within two weeks of initial tryout date:

- USA Swimming registration form and fees
- Signed Rainbow Aquatics Terms & Conditions form
- \$60 initiation fee assessed to all new swimmers; \$60 reactivation fee assessed to all current swimmers who suspend and reactivate their membership at a later time. Note: Reactivation fee excludes coach-designated winter break period for Novice Group.

### **Monthly Dues & Billing** (effective 10/1/19; see Dues Schedule on page 2 for additional details)

Months are not pro-rated, and dues are not waved for vacation absences. Dues and fee schedule subject to change without notice. When your swimmer is moved from one group to another, you will be billed the monthly dues for the highest group in which he/she participates.

<b>Senior Group:</b>	<b>\$75/month</b>
<b>Intermediate Group:</b>	<b>\$60/month</b>
<b>Beginner Group:</b>	<b>\$50/month</b>
<b>Novice Group:</b>	<b>\$85/month</b>

- USA Swimming registration fees and Rainbow Aquatics monthly dues are not prorated and are non-refundable. Monthly dues are to be paid within 10 days of receiving your bill. Dues are used to pay coaches and pool rental fees; prompt payment is therefore critical to the operation of the team. All bounced or returned checks will incur a \$25 nonrefundable fee.
- If a swimmer requests to stop swimming (temporarily or permanently), notify coaches **and** the Board of Directors in writing by the 15<sup>th</sup> of the **prior** month for monthly dues to be suspended at the end of the next month. Each swimmer will incur a \$60 reactivation fee upon return.
- Novice Group swimmers will not incur a reactivation fee for coach-determined breaks (e.g., winter months). If a Novice swimmer temporarily stops swimming outside the coach-determined break, notify the coach **and** Board of Directors in writing by the 15<sup>th</sup> of the **prior** month for dues to be suspended at the end of the next month. If the swimmer returns outside of the coach-determined break, a \$60 reactivation fee will be incurred for each swimmer. Monthly dues are not prorated.
- If a swimmer transfers to another team, monthly dues for the month in which your swimmer leaves, plus any outstanding fees, are considered an obligation to Rainbow Aquatics and must be paid before transfer papers will be approved.

### **Meet Entries**

- Swimmers must declare their availability to swim through Rainbow Aquatics TeamUnify site or app before entry deadline or they will not be entered in the meet.
- Swim meet entry fees will be charged to your account as your swimmer participates in meets. The charges will show up in the next month's billing. All meet entry fees are non-refundable.
