

CAST Dues, Membership and Fundraising Commitment

1. **MONTHLY DUES:** Monthly dues are DUE BY THE 1ST OF EACH MONTH and based upon the swimmer's squad as of the first of the month. **Sibling Fees:** Families with more than one swimmer will be discounted 15% of the appropriate monthly fee for the second swimmer and each additional swimmer. Sibling discounts do not apply to the C squad swimmers. Monthly dues for high school swimmers, swimming with their high school, who wish to swim with CAST as well, are \$60 per month

during September and October only. A \$10 late fee will be assessed on the 10th of the month. Families 2 months in debt will not be allowed to swim or attend swim meets until bill is current paid in full (no partial payments). **Withdrawal from the team requires a written notice.**

2. **All swimmers must be members in good standing of the Kroc Center.** A discount on the Kroc membership is available to all CAST swimmers.

3. **ANNUAL FUNDRAISING:** The fundraising commitment is annual, per swimmer, with a fundraising for multi swimmer families to your 2 highest level swimmers. Swimmers may earn credit toward the fundraising commitment by participation in the major team fundraising efforts. We encourage families to fundraise beyond their commitment. If you exceed your annual commitment, then you will receive 15% of the excess fundraising profit as a credit on your account if designated by family. This is a credit only and may not be cashed out and is forfeited if your swimmer leaves the team. If your fundraising commitment is not met by July 1st, the balance will be due at that time. Fundraising will be prorated based on joining or termination date.

4. All swimmers, including C Squad, must be registered with USA Swimming. Swimmers pay the annual registration fee for USA Swimming membership good from September 1st, 2019 - December 31st, 2020.

5. Parent Volunteer Program. CAST has put in place a requirement for our families to contribute a minimum number of 10 hours per swim year. Unfulfilled hours will be billed at a rate of \$15 per unfulfilled hours on your next monthly statement upon leaving the team or July 1st 2020.

6. The CAST board has established a scholarship fund to aid families for whom any increases represent a financial hardship. CAST Crocs Scholarship Application must be completed and submitted to a board member.

Payment Policies and Authorization for Direct Payments (ACH Debits/ Credit)

CAST families must prepay membership dues on a monthly basis. Dues **must** be paid via automatic credit card payment or electronic debit from a checking/ savings account. Automatic credit card payments will include a 3% transaction fee. Meet entry fees, swim apparel, team travel fees, etc. will be billed to your CAST account monthly. **Payment in full is due by the 1st of each month** and

is considered past due on the 5th of each month. A late fee of \$10.00 will applied to each outstanding balance on the 5th of each month.

All CAST bills are available to view on our website. All account invoices will be made available on the 31st of each month and will be due on the 1st.

I(We) hereby authorize Coeur d'Alene Area Swim Team, Inc. (CAST) to collect payment via ACH debit/credit for all invoice balances and acknowledge these **payments will be made on the 1st of each month**. Any adjustment to my invoices or cancellation of swimmer membership **must be received by CAST in writing 30 business days prior to such adjustment being withdrawn. This authorization will remain in effect until notice of termination is submitted in writing to CAST. Please be advised there will be no proration of monthly membership dues.** I (we) acknowledge that the origination of ACH transactions to my (our) account must comply with the provisions of U.S. law.

CAST Volunteer Agreement

We understand that the Coeur d'Alene Area Swim team will host at least two swim meets/events during the 2019/2020 swim season.

We understand that any unfilled hours will be billed at a rate of \$15.00 per hour at the conclusion of each event. This policy is not to be punitive, but simply to establish an equitable workload for each family.

We also acknowledge that we have received an official time card which is to be turned in to the meet director and signed by our committee lead at the conclusion of each CAST hosted event. As a member of CAST we recognize that our family is required to volunteer a minimum of **10 hours** of service per CAST hosted event. Swim meets and other hosted events are a source of revenue for CAST and are necessary in order to keep monthly dues to a minimum.
