

Ellensburg Area Swim Team Membership and Dues Agreement

September 1, 2021- August 31, 2022:

WHEREAS, it is acknowledged by the membership that the operation of a competitive age group swim team available to the area's youth is an important and worthwhile endeavor; and

WHEREAS, it is further acknowledged that, to successfully operate said swim team, consistent and regular revenue must be received to allow for the payment of salaries, taxes, and traveling expenses for the coaching staff and equipment purchases; and

WHEREAS, an agreement needs to be established between the club and the general membership to allow for the common understanding of obligations and responsibilities.

A summary of volunteer and financial obligations is listed below:

Trial Period (up to one month)	Month of Tryout	Have to pay USA Swim Registration	New swimmers pay a nonrefundable USA Swimming registration fee but will not be charged monthly membership dues until the 1st day of the next month.
USA Swimming Registration	Time of Registration	\$15 Or \$81	Required by USA Swimming and Inland Empire Swimming. \$15 Flex Registry – swimmer can attend two swim meets, excluding Junior Olympics and Champs. Membership can be upgraded to Year Round as needed, difference in membership price will apply. – Swim meet fees still apply. \$81 Year Round Registry – can attend all swim meets as wanted including Junior Olympics and Champs. – Swim meet fees still apply.
Swim-a-Thon (Fundraising)**	March-April	\$200/swimmer \$400 Max/family	This is a per swimmer charge that can be reduced via Swim-a-Thon donations. Contributions to our annual Swim-a-Thon which typically takes place in March or April; otherwise the Fundraising Dues Offset will be billed on July 1st.

Gold Athletes working towards Champs or Zones Times	\$110
Silver Athletes working towards Jr. Champs or Champs times.	\$105
Bronze Pre-competition to Jr. Champs. This is typically beginners just starting the team.	\$90
Pre-Comp Pre-competition, just starting and learning about swim team	\$75
Swim School Brand new swimmers not ready for swim team – Coach authorization	\$60
Swim Lessons Separate lessons charged out individually. Will be billed out and charged on the first of the following month.	

****Family Discount:** Any family who has three or more swimmers will receive a ten percent (10%) discount on the monthly dues charged for each swimmer after the highest-level swimmer (excludes Masters, Pre-comp, Swim School, and Swim Lessons).

E-mail the Registrar – Megan Dickinson (EASTteamregistrar@gmail.com) by the 15th of the prior month to request to move your swimmer in or out of the water. Notification must be made by the 15th of the month prior to month the membership is to be cancelled. Otherwise the swimmer(s) will be charged that month's dues as well.

Home Meet	Month of Meet	\$10 Per Meet or a	This fee is to help offset the cost of hospitality food and stock the concessions for home meets.
Late Payment Fee	16th of month when	\$25	Please keep your account current to avoid late fee charges.
Unworked Volunte	Billed in June	\$40 per unworked hour	Each family is required to volunteer 6 hours per year to help the team host home meets, and help at away meets.
Meet Fees	Billed 1st of the month	Varies	Each meet has a surcharge of \$12-\$20 per swimmer. Each event entered is \$3-\$4.? This amount will be billed
