



## 2019-2020 Membership Agreement Addendum

This addendum must be signed by a parent and board member prior to the athlete attending his or her first practice for the 2019-2020 swim year.

### 1. Monthly Training Fees (Select ONE of the following Options):

**INSTALLMENT PLAN:** I agree to pay monthly training fees for my swimmer's group level starting the month of registration and ending July 31, 2020. If my swimmer decides to leave the team before July 31, 2020, my account will be charged the \$250 fundraising fee or the difference between the installment fee and seasonal fee for the months my swimmer is in the water, whichever is smaller.

\_\_\_\_\_ **FUNDRAISING REQUIREMENT:** I acknowledge that this payment plan has a minimum \$250 fundraising requirement (per swimmer), which must be met by June 1, 2020. If the fundraising requirement is not met by this date, my account will be billed for whatever portion of this fee has not been met.

**PAID UP FRONT PLAN:** I agree to pay training dues for the whole year, upfront, with a 5% discount. Payment is due no later than September 30, 2019. No refunds.

\_\_\_\_\_ **FUNDRAISING REQUIREMENT:** I acknowledge that this payment plan has a minimum \$250 fundraising requirement (per swimmer), which must be met by June 1, 2020. If the fundraising requirement is not met by this date, my account will be billed for whatever portion of this fee has not been met.

**SEASONAL PLAN** I acknowledge that I will only pay dues for the months in which my swimmer is in the water. I will notify the [billing@velocity-swimming.com](mailto:billing@velocity-swimming.com) email account by the 20<sup>th</sup> of the month if my swimmer will NOT be in the water the following month. Failure to notify the billing email by the 20<sup>th</sup> will incur training fee charges for the following month.

### 2. Swim Meets

\_\_\_\_\_ I acknowledge that all home swim meets are required attendance for my swimmer. If, for some reason, my swimmer is not able to attend a home meet, I must let the head coach know AT LEAST 30 days prior to the meet.

\_\_\_\_\_ If my swimmer misses more than 1 home meet, my account will be charged \$50 per missed home meet

\_\_\_\_\_ If I sign my swimmer up for an away meet, I am responsible for the meet fees incurred for the meet, even if my swimmer is not able to attend the meet.

\_\_\_\_\_ I acknowledge that all swim meets have different levels of fees. It is my responsibility to read the meet sanction and membership agreement to be aware of additional fees.

### 3. Volunteer Requirements

\_\_\_\_\_ I acknowledge that all home meets come with volunteer hour requirements. Failure to meet my volunteer hour requirements will incur a \$25 per hour charge for every unworked hour.

### 4. Team Gear

\_\_\_\_\_ My swimmer is required to wear a Velocity team cap when participating in any swim meet. Team caps cost \$10 and are available for purchase any time during practice or meets.

\_\_\_\_\_ I acknowledge that Velocity is an Arena sponsored swim team and will make every effort to outfit my swimmer in an Arena brand suit when they are competing in a meet.

\_\_\_\_\_ I am aware that the Piranha (Steel), Shark (Bronze), and Wahoo (Senior) swim groups have certain equipment requirements and I will make sure my swimmer has the equipment they need to have a successful practice.

**5. Team Account/Billing/Email:**

\_\_\_\_\_ I acknowledge that team communication is done through email and that it is my responsibility to check my email often for important team information

\_\_\_\_\_ I acknowledge that there is a \$0.30 per transaction fee plus 2.95% of the total transaction amount for each credit card or ACH transaction paid through the team website.

\_\_\_\_\_ I acknowledge that it is my responsibility to pay my team bill on time and that invoices must be paid in full by the 15<sup>th</sup> of the month, or a \$25 late fee will be charged to my account.

\_\_\_\_\_ I acknowledge that if my account is more than 30 days past due, my swimmer is not eligible to participate in swim meets until my account is paid in full. If my account is more than 60 days past due, my swimmer is not eligible to practice with the team until my account is paid in full.
