2020-2021 Membership Agreement

This agreement must be signed by a parent and board member prior to the athlete attending his or her first practice for the 2020-21 swim year. Please initial next to each line

1. Monthly Training Fees:

_____ I agree to pay monthly training fees for my swimmer's group level starting the month of registration and ending August 31, 2021.

1a. Maintenance Fees

_____ I understand that my account may be charged a monthly maintenance fee of \$50 per month in one or more of the following circumstances: (a) the team must meet virtually or in small groups for dryland only if we do not have access to pool space and/or (b) I have a high school swimmer who will be swimming with their high school team for two months and my swimmer will not be practicing with the team during this time period.

1b. Dues Free Month Requirements

_____ I understand that August 2021 will only be dues free if the following requirements have been met: (a) dues have been paid in full from September 1, 2020 - July 31, 2021 and (b) my fundraising obligation has been paid in full by July 31, 2021

2. FUNDRAISING REQUIREMENT:

_____ I acknowledge that there is a \$250 fundraising requirement (per swimmer), which must be met by June 30, 2021. If the fundraising requirement is not met by this date, my account will be billed for whatever portion of this fee has not been met.

3. Swim Meets

_____ I acknowledge that all home swim meets are required attendance for my swimmer. If, for some reason, my swimmer is not able to attend a home meet, I must let the head coach know AT LEAST 30 days prior to the meet.

_____ I understand that by signing my swimmer up for an away meet, I agree to pay an equitable portion of the attending coach's travel expenses.

_____ If I sign my swimmer up for an away meet, I am responsible for the meet fees incurred for the meet, even if my swimmer is not able to attend the meet.

_____ I acknowledge that all swim meets have different levels of fees. It is my responsibility to read the meet sanction to be aware of additional fees.

4. Volunteer Requirements

_____ I acknowledge that all home meets come with volunteer hour requirements. Failure to meet my volunteer hour requirements will incur a \$25 per hour charge for every unworked hour.

5. Team Gear

_____ My swimmer is required to wear a Velocity team cap when participating in any swim meet. Team caps cost \$10 and are available for purchase any time during practice or meets.

_____ I acknowledge that Velocity is an Arena sponsored swim team and will make every effort to outfit my swimmer in an Arena brand suit when they are competing in a meet.

_____ I am aware that the Piranha, Shark, and Wahoo swim groups have certain equipment requirements and I will make sure my swimmer has the equipment they need to have a successful practice.

6. Team Account/Billing/Email:

_____ I acknowledge that team communication is done through email and that it is my responsibility to check my email often for important team information

_____ I acknowledge that there is a \$0.30 per transaction fee plus 2.95% of the total transaction amount for each credit card or ACH transaction paid through the team website.

_____ I acknowledge that it is my responsibility to pay my team bill on time and that invoices must be paid in full by the 15th of the month, or a \$25 late fee will be charged to my account.

_____ I acknowledge that if my account is more than 30 days past due, my swimmer is not eligible to participate in swim meets until my account is paid in full. If my account is more than 60 days past due, my swimmer is not eligible to practice with the team until my account is paid in full.
