

Stateline Swim Conference

Updated September 2002

Purpose: To provide a friendly competition among teams in the state line area

Teams: Byron Tigersharks (BTS), Freeport Aquatic Swim Team (FAST), Morrison Seahorse Swim Club (MSSC), Rockford Marlins Swim Club (RMSC), and Sterling Stingrays Swim Club (SSSC)

Meets: Teams will compete in a friendly atmosphere to promote competition

All meets will follow USA Swimming Rules and Regulations

Meet Organization

- At least one timer per lane and two officials are needed. Each team should supply at least three (3) timers and one official. The official should have knowledge of all rules and regulations and preferably be a certified USA Swimming official. At least one official (Referee) needs to be certified by USA Swimming.
- The order of events will be as described in these rules. This order of events may be changed by mutual agreement of all teams in the meet.
- Scoring
 - Dual Meets Individual Events 5-3-1 Relays 7-5-3
 - Tri-Meets Individual Events 6-4-3-2-1 Relays 8-5-4-3-2
 - Conference Champs USA Swimming 12 place scoring
- Event limitations for all meets shall be, an individual swimmer may not swim more than three (3) individual events and no more than two (2) relays. Each team is permitted to enter the following:
 - Dual Meets 3 Swimmers per event
 - Tri-Meets 4 Swimmers per event
 - Conference Championships 6 Swimmers per event with a maximum of four (4) allowed to score in that event (*adopted April 2001*)
 - * Dual and Tri-Meet limits may be changed by mutual agreement of the coaches
- Awards for dual and tri-meets will be the responsibility of the home team. They may or may not give them out.
- Awards for the Championship Meet will be given to twelve (12) places and be the responsibility of the home team to provide, but the cost will be divided by all teams in the conference, whether you participate or not.
- All meets will be seeded according to USA Swimming Rules (*Adopted September 2002*)

- Lineup sheets shall be submitted before dual and tri-meets. Hy-Tek entries would be greatly appreciated for those with the capability. The championship deadline will be no later than one (1) week before the meet.
- Home team shall notify visiting team of any changes of time and place as soon as possible after agreed upon.
- Sanctions should be acquired by the home team for all meets.
- All changes must be mutually agreed upon by both teams Head Coaches or their representatives.
- Winter Championships will be held Superbowl weekend.
- Summer Championships will be held the 2nd week of July.
- All teams shall submit their current roster, according to Illinois Swimming Inc., with their Conference Championship Meet entries. Only those swimmers whose names appear on the roster shall be permitted to participate in the Championship Meet.
